General remarks and official action taken:

This is a default order taken against Kade Austen Mitchell and Mitchell Adjusting International, LLC (Respondents) because Respondents misappropriated funds, received excessive commissions, forged the signatures of numerous clients on settlement checks, violated the code of ethics for public insurance adjusters, and failed to notify the department of other states' administrative actions. Respondents did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondents' licenses.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

 On April 24, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.

- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondents' last known addresses provided in writing to the department, , Clear Lake Shores, Texas 77565 and Kemah, Texas 77565. The Notice of Hearing and Original Petition were also sent by electronic mail and to an additional address associated with Respondents: Seabrook, Texas 77586-1636.
- 4. Respondents failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 84.021-84.044, 4001.002, 4001.252, 4005.101, 4005.102, 4005.107, 4102.051, and 4102.104; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. Code § 1.89.

Order

It is ordered that any licenses held by Kade Austen Mitchell and Mitchell Adjusting International, LLC are revoked. It is further ordered that Kade Austen Mitchell and Mitchell Adjusting International, LLC must pay, jointly and severally, restitution to P.T., as laid out in the petition, in the amount of \$28,928.24; to V.S., as laid out in the petition, in the amount of \$39,613.18; to New Hope Baptist Church, as laid out in the petition, in the amount of \$150,000; and to Mae-Cliff, LLC, as laid out in the petition, in the amount of \$113,170.56.

It is ordered that Kade Austen Mitchell and Mitchell Adjusting International, LLC pay the above restitution by cashier's check or money order within 60 days of the date of this order. Written confirmation of payment must be provided to the department within 60 days of the date of this order by emailing it to EnforcementReports@tdi.texas.gov. A copy of this order will be provided to law enforcement or other appropriate administrative agencies for further investigation as may be warranted.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Kade Austen Mitchell and Mitchell Adjusting International, LLC. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. INS. CODE §§ 82.051–82.055, 84.021–84.044, 4001.002, 4001.252, 4005.101, 4005.102, 4005.107, 4102.051, and 4102.104, and Tex. Gov't Code §§ 2001.051–2001.178.

Factual Allegations

Licensure

- Kade Austen Mitchell (Mitchell), individual identification number 2128559, holds a
 public insurance adjuster license originally issued by the Texas Department of
 Insurance on February 20, 2020. The license was originally issued to Mitchell under
 his former name, Kade Austen Aga.
- 2. On December 5, 2019, Mitchell legally changed his name to Kade Austen Mitchell. Mitchell notified the department of his name change on March 4, 2020.
- 3. Mitchell Adjusting International, LLC (Mitchell Adjusting), firm identification number 169490, held a public insurance adjuster firm license originally issued by

the department on May 22, 2020. Mitchell Adjusting's firm license expired on May 22, 2022, due to its failure to renew.

4. On March 20, 2020, Mitchell filed with the Texas Secretary of State as the registered agent and managing member of Mitchell Adjusting. Mitchell subsequently filed for licensure for Mitchell Adjusting and is listed as the designated responsible licensed person for the firm.

Related Enforcement Action

- 5. On October 12, 2022, a hearing on the merits in the matter of Texas Department of Insurance v. Andrew Joseph Mitchell¹ was held. Andrew Mitchell is Mitchell's father and was also a designated responsible licensed person for Mitchell Adjusting. The department alleged that Andrew Mitchell willfully violated insurance laws of this state; misappropriated, converted to his own use, or illegally withheld money belonging to an insured, insurer, or beneficiary; engaged in fraudulent or dishonest acts; conducted the business of insurance without a license; failed to conduct business fairly; received commissions exceeding 10% of the amount of the insurance settlement on multiple claims; and failed to notify the department of administrative actions taken against him. The allegations in the Andrew Mitchell matter are not repeated here.
- 6. The presiding ALJ issued a proposal for decision on December 20, 2022, recommending Andrew Mitchell's license be revoked, ordering him to pay restitution to the victims, ordering him to pay an administrative penalty, and recommending the commissioner issue a cease and desist order.
- 7. Andrew Mitchell's licenses are revoked in Washington, Louisiana, and Colorado. He is currently incarcerated in Louisiana and indicted in Kimble County, Texas, on charges related to theft of proceeds issued to insureds for the settlement of their claims.

Fraudulent and Dishonest Conduct

G.M.

- 8. On February 14, 2021, G.M.'s home sustained damage due to Winter Storm Uri. G.M. filed a claim with her insurer, Allstate, on February 16, 2021.
- 9. On May 18, 2021, G.M. retained the services of Mitchell Adjusting to assist with her claim. Mitchell Adjusting sent an engagement letter to Allstate dated May 21, 2021.
- 10. On February 16, 2022, Allstate issued a check payable to "[Mitchell Adjusting] and [G.M.] and TIAA FSB ISAOA ATIMA c/o Loan Care LLC" in the amount of \$35,995.36. Upon receipt of the check, and without the knowledge or consent of the insured, Mitchell forged the insured's signature and deposited the funds into Mitchell Adjusting's bank account.
- 11. The insured initially received \$5,000 of the \$35,995.36 from Mitchell, and did not receive the remainder of the funds owed until July 2022—five months after the funds were issued.
- 12. Mitchell misappropriated the funds issued in payment for G.M.'s claim by failing to timely remit the funds to G.M., a violation of the Insurance Code.

P.T.

- 13. On February 16, 2021, P.T.'s home sustained damage due to Winter Storm Uri. P.T. filed a claim with her insurer, Allstate Insurance Company (Allstate), on February 18, 2021.
- 14. On March 14, 2021, Allstate issued a payment to P.T. in the amount of \$19,658.45. P.T. received these funds without issue.
- 15. On April 27, 2021, P.T. retained the services of Mitchell Adjusting to assist with her claim.

- 16. On July 7, 2022, Allstate issued a check payable to "[Mitchell Adjusting] and [P.T.]" in the amount of \$28,928.24. Upon receipt of the check, and without the knowledge or consent of P.T., Mitchell forged the insured's signature and deposited the funds into Mitchell Adjusting's bank account.
- 17. Mitchell retained the entirety of the proceeds issued on July 7, 2022, resulting in a commission in excess of 10%, a violation of the Insurance Code.

V.S.

- 18. On February 19, 2021, V.S.'s home sustained damage due to Winter Storm Uri. V.S. filed a claim with her insurer, UPC Insurance (UPC), on February 20, 2021.
- 19. On May 12, 2021, V.S. retained the services of Mitchell Adjusting to assist with her claim. Mitchell Adjusting sent an engagement letter to UPC dated May 17, 2021.
- 20. On March 11, 2022, UPC issued a check payable to "[V.S.] and CrossCountry Mortgage LLC ISAOA/ATIMA and [Mitchell Adjusting]" in the amount of \$39,613.18. Upon receipt of the check, and without the knowledge or consent of the insured, Mitchell forged the insured's signature and deposited the funds into Mitchell Adjusting's bank account.
- 21. Mitchell retained the entirety of the proceeds issued on March 11, 2022, resulting in a commission in excess of 10%, a violation of the Insurance Code.

New Hope Baptist Church

- 22. On August 29, 2021, the New Hope Baptist Church (New Hope) complex sustained damage from Hurricane Ida. New Hope filed a claim with its insurer, Nationwide Mutual Insurance Company (Nationwide), on September 16, 2021.
- 23. On December 15, 2021, New Hope, through its representative E.B., retained the services of Mitchell Adjusting to assist in the claims process.
- 24. Nationwide issued two \$75,000 checks for this claim on March 16, 2022, totaling \$150,000. These checks were made payable to "[New Hope] and Fidelity Bank ISAPA/ATIM and [Mitchell Adjusting]." Upon receipt of the checks, and without

> the knowledge or consent of the insured, Mitchell forged the signatures of both New Hope and Fidelity Bank and deposited the funds into Mitchell Adjusting's bank account.

- 25. Mitchell retained the entirety of the proceeds issued on March 16, 2022, resulting in a commission in excess of 10%, a violation of the Insurance Code.
- 26. On or about May 10, 2022, E.B. contacted Nationwide to inquire about the status of New Hope's claim. E.B. stated Mitchell and Mitchell Adjusting were no longer responding to inquiries from New Hope. While discussing the claim with Nationwide, E.B. was informed of the two checks sent in March.
- 27. E.B. maintains the checks were not signed by a representative of New Hope.

Mae-Cliff, LLC

- 28. On August 29, 2021, property owned by Mae-Cliff, LLC (Mae-Cliff) sustained damage due to Hurricane Ida. Mae-Cliff filed a claim with its insurer, Nationwide, on September 2, 2021.
- 29. On March 24, 2022, Mae-Cliff retained the services of Mitchell Adjusting to assist in the claims process.
- 30. On June 22, 2022, Nationwide issued a check payable to "Kade Mitchell and Mae-Cliff c/o [J.D.]" in the amount of \$113,170.56. Upon receipt of the check, and without the knowledge or consent of the insured, Mitchell forged the insured's signature and deposited the funds into Mitchell Adjusting's bank account.
- 31. Mitchell retained the entirety of the proceeds issued on June 22, 2022, resulting in a commission in excess of 10%, a violation of the Insurance Code.

Other State Administrative Actions

32. On September 14, 2021, the Colorado Department of Insurance suspended Mitchell's license. Mitchell did not notify the department of the suspension.

33. On November 30, 2021, the Louisiana Department of Insurance ordered Mitchell to pay a monetary penalty due to his failure to report other state action(s). Mitchell did not notify the department of the administrative action.

Legal Allegations

- 1. Mitchell willfully violated an insurance law of this state as contemplated in Tex. INS. Code § 4005.101(b)(1).
- 2. Mitchell misappropriated, converted to his own use, or illegally withheld money belonging to an insured, insurer, or beneficiary, in violation of Tex. Ins. Code § 4005.101(b)(4).
- 3. Mitchell engaged in fraudulent or dishonest acts or practices in violation of Tex. Ins. Code § 4005.101(b)(5).
- 4. The commissioner has adopted a code of ethics for public insurance adjusters under 28 Tex. Admin. Code § 19.713, pursuant to Tex. Ins. Code § 4102.005. Mitchell failed to comply with this code of ethics because he failed to conduct business fairly with his clients, insurance companies, and the public, in violation of 28 Tex. Admin. Code § 19.713(b)(1).
- 5. Mitchell received commissions for services exceeding 10 percent of the amount of the insurance settlement on the claim, in violation of Tex. Ins. Code § 4102.104 and 28 Tex. Admin. Code § 19.713(b)(4).
- 6. Mitchell did not notify the department of the administrative actions taken against him, in violation of Tex. INS. CODE § 4001.252.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Kade Austen Mitchell's license;
- 2. revoking Mitchell Adjusting International, LLC's license;
- 3. directing Kade Austen Mitchell to pay an administrative penalty under Tex. INS. CODE §§ 84.021–84.022;
- 4. directing Kade Austen Mitchell to make restitution to victims under Tex. Ins. Code § 82.053; and
- 5. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
