General remarks and official action taken:

This is a default order taken against Pedro Alcantar Morales (Respondent) because he was placed on deferred adjudication for a felony offense of indecency with a child by contact, was sentenced to 10 years community supervision, and ordered to serve a term of imprisonment for 180 days. Morales is currently imprisoned at the Bexar County Jail. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

1. On May 22, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, P.O. Box 3035, McAllen, Texas 78502. The Notice of Hearing and Original Petition were also sent by electronic mail and to one additional address associated with Respondent: Pedro Alcantar Morales, [REDACTED] [REDACTED] San Antonio, Texas 78207. The department also sent the Notice of Hearing and Original Petition to Respondent's criminal attorney, Jesus Villalobos at 8701 N. 23rd Street, McAllen, Texas 78504.
4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law


1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.051, and 4054.051; 28 TEX. ADMIN. CODE § 1.502; TEX. OCC. CODE §§ 53.021-53.023; and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
3. The department provided proper notice of the hearing under TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054; and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Pedro Alcantar Morales. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.051, and 4054.051; 28 TEX. ADMIN. CODE § 1.502; TEX. GOV'T CODE §§ 53.021-53.023; and TEX. GOV'T CODE §§ 2001.051-2001.178.

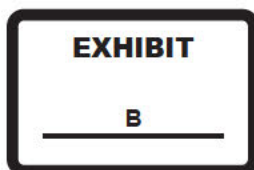
Factual Allegations

Licensure and Background

1. Pedro Alcantar Morales (Morales), individual identification number 40753, holds a general lines agent license with a life, accident, and health qualification issued by the Texas Department of Insurance (TDI) on November 7, 1975, and a property and casualty qualification, issued by TDI on January 14, 1977.

Criminal History

2. On April 17, 2023, Morales pled guilty to and was placed on deferred adjudication for the 2nd degree felony offense of indecency with a child by contact, in cause no. 2020CR7285, in the 437th District Court in Bexar County, Texas. The court

sentenced Morales to 10 years community supervision and ordered him to pay a \$1,000 fine and \$480 in court costs.

3. Morales was also ordered to serve a term of imprisonment in the Bexar County Jail for 180 days.
4. Morales was also ordered to comply with sex offender registration under Chapter 62, Code of Criminal Procedure.
5. As of the date of this petition, Morales appears to have failed to register as a sex offender.
6. On or about April 17, 2023, Morales surrendered himself to serve his term of imprisonment in the Bexar County Jail.

Legal Allegations

1. Morales committed a felony offense that directly relates to the duties and responsibilities of the licensed occupation, as contemplated in 28 TEX. ADMIN. CODE §§ 1.502(d) and (f).
2. Morales committed an offense that TDI considers to be of such serious nature that it is of prime importance in determining fitness for licensure or authorization, as contemplated by 28 TEX. ADMIN. CODE § 1.502(e).
3. Morales committed a felony involving moral turpitude, as contemplated by 28 TEX. ADMIN. CODE § 1.502(e)(3).
4. Morales committed an offense with the essential elements of an offense against a person as described by TEX. PENAL CODE § 21.11, as contemplated by 28 TEX. ADMIN. CODE § 1.502(e)(4)(H).
5. Pursuant to TEX. OCC. CODE § 53.021(c)-(d), the commissioner may revoke Morale's license and consider him to have been convicted of the offense for purposes of Section 53.021 because:

- a. Morales has been charged with an offense described by Article 62.001(5)(A), Code of Criminal Procedure, specifically, felony indecency with a child by contact under TEX. PENAL CODE § 21.11; and,
 - b. Morales has not completed his period of supervision.
6. Pursuant to TEX. OCC. CODE § 53.021(d)(2), TDI determined that:
 - a. Morales continues to pose a continued threat to public safety; and
 - b. employment of Morales in the licensed occupation will create a situation in which he has the opportunity to repeat the prohibited conduct.
7. TDI considers Morales to have been convicted of the above described offense and Morales has been imprisoned following that felony adjudication that is treated as a conviction for purposes of TEX. OCC. CODE § 53.021. As contemplated in TEX. OCC. CODE § 53.021(b) and (d), his license must be revoked by operation of law.
8. TDI guidelines, 28 TEX. ADMIN. CODE § 1.502(c)-(e), emphasize that TDI:
 - a. considers it very important that license holders be honest, trustworthy, and reliable;
 - b. may revoke a license if TDI determines that the license holder has committed a felony or misdemeanor, or has engaged in fraudulent or dishonest activity that directly relates to the duties and responsibilities of the licensed occupation;
 - c. considers any felony involving moral turpitude to be a crime of prime importance when determining fitness for licensure pursuant to 28 TEX. ADMIN. CODE § 1.502(e)(3); and,
 - d. considers an offense with the essential elements of an offense against a person to be a crime of prime importance when determining fitness for licensure pursuant to 28 TEX. ADMIN. CODE § 1.502(e)(4)(H).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

1. revoking Pedro Alcantar Morales' license;
2. imposing any other just and appropriate relief to which the department may be entitled to by law.

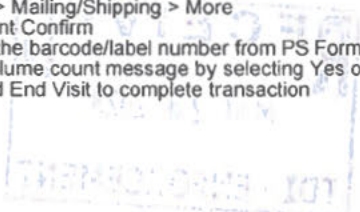

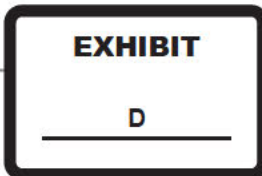

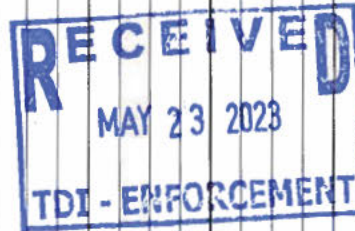
