General remarks and official action taken:

The subject of this default order is whether a general lines life, accident, and health license should be issued to William Earl Garrett (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

- On June 29, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

 Dallas, TX 75206, and to the electronic mail address on file with the department.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101, and 4054.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; Tex. Admin. Code § 1.502(e); and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.



ORIGINAL PETITION

The Texas Department of Insurance seeks to deny William Earl Garrett's license application. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051; Tex. Admin. Code §§ 1.502; Tex. Occ. Code §§ 53.021 – 53.023; and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

<u>Application</u>

- 1. William Earl Garrett (Garrett) applied for a general lines life, accident, and health license to the Texas Department of Insurance (TDI) on November 12, 2019.
- 2. On January 13, 2020, TDI proposed to deny the license based on Garrett's criminal history, and on February 18, 2020, TDI received Garrett's request for a hearing on this matter.

Criminal History

3. On February 13, 2003, Garrett pleaded guilty to "solicit minor indecency with a child", in the 292nd Judicial District Court of Dallas County, Texas, in exchange for a 10-year probationary period of deferred adjudication.

- 4. On October 21, 2004, the Dallas County District Attorney filed a motion to proceed with an adjudication of guilt, citing 2 violations of his probationary terms: (1) failure to pay probation fees, and (2) unsuccessful discharge from counseling.
- 5. On November 4, 2004, Garrett's deferred probation was revoked, and Garrett was adjudicated guilty of "solicit minor indecency with a child", a third-degree felony offense, and was sentenced to 10 years confinement.
- 6. April 14, 2008, the Fifth District Court of Appeals modified the judgment in cause no. 05-04-01720-CR to indicate the correct offense committed by Garrett, "criminal solicitation of a minor for sexual assault", a third-degree felony offense.
- 7. One June 11, 2012, Garrett was released from custody to mandatory supervision, and was discharged on October 17, 2014.
- 8. Garrett is a registered sex offender.

Legal Allegations

- 1. Garrett has been convicted of a felony offense, grounds for which the department may deny his license application, under Tex. Ins. Code § 4005.101(b)(8).
- 2. Garrett committed an offense that the department considers to be of such a serious nature that it is of prime importance in determining fitness for licensure, as contemplated by 28 Tex. Admin. Code § 1.502(e)(3).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying William Earl Garrett's license application and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
