General remarks and official action taken:

This is a default order taken against Byron Anthony Johnson (Respondent) because he has: engaged in fraudulent and dishonest acts or practices; engaged in an unfair method of competition or an unfair or deceptive act or practice in the business of insurance; uses a false, misleading, confusing, or deceptive insurance advertisement; failed to identify the person or entity responsible for that advertisement; and, he is not appointed with the insurers he claims that he has authority to act for and has been advertising and soliciting using those insurers' names for more than 30 days. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license and orders Respondent to cease and desist from advertising to Texas residents through the website [REDACTED]

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

1. On April 14, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.

2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, [REDACTED], Wesley Chapel, Florida 33544. The Notice of Hearing and Original Petition were also sent by electronic mail and to an additional address associated with Respondent, [REDACTED], Tampa, Florida 33612.
4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, 4051.051, and 4054.051; and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054; and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

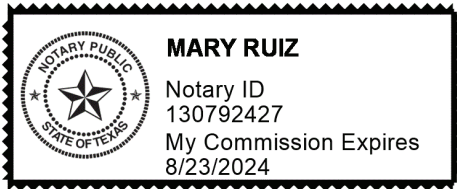

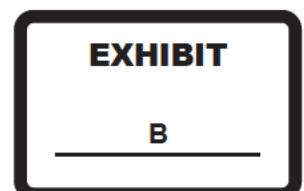
The Texas Department of Insurance seeks to take disciplinary action against Byron Anthony Johnson. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, 4051.051, and 4054.051; and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

1. Byron Anthony Johnson (Johnson), individual identification number 1824524, holds a non-resident general lines agent license with a property and casualty qualification issued by the department on October 8, 2017.
2. The department issued a life, accident, and HMO qualification to Johnson on February 25, 2021.
3. Johnson has a Texas non-resident license because he lives in Florida.



False, Misleading, and Deceptive Insurance Advertising

4. On July 28, 2021, Johnson informed TDI that he uses the website [REDACTED] (hereafter, the Obamacare website) to advertise and solicit business for his services as an insurance agent in Texas.
5. Upon information and belief, Johnson owns, controls, and dictates the content of the Obamacare website.
6. The Obamacare website is active, fully operational, and viewable by citizens of Texas and other states. It currently offers Texas consumers quotes for health insurance plans and tells consumers to “fill out the form to get your instant free quote.”
7. On the Obamacare website, Johnson does not identify any licensed agent or agency’s name, assumed name, or license number anywhere.
8. The Obamacare website purports to be or gives an impression that it is a government website, a government-sponsored website, or a government-operated website, when it is none of those things. The symbols and phrases the Obamacare website displays and uses to mislead and deceive consumers include:
 - a. The seal of the U.S. House of Representatives on the “Contact Us” subpage;
 - b. A red, white, and blue symbol associated with President Barack Obama’s 2008 presidential campaign, generally known as the “Obama logo” in numerous locations on the website;
 - c. The phrase “Obamacare ACA” as the title of the website on its homepage; and,
 - d. A subpage on the website is entitled “Obamacare Health Insurance” showing a photograph of former President Barack Obama, and also generally describes the Patient Protection and Affordable Care Act (or ACA).
9. The Obamacare website also purports to operate as a non-profit, charitable organization under the federal Internal Revenue Code section 501(c)(3) because its domain name ends with “.org”. This too is misleading and deceiving to Texas consumers because Johnson is controlling the Obamacare website and he is not a

non-profit, charitable organization. In fact, Johnson seeks to earn commissions by quoting and then selling insurance products to Texas residents through the Obamacare website, and to indeed, make a profit.

10. Johnson's operation of the Obamacare website is false, deceptive, and misleading to Texas consumers.

Lack of Appointments

11. On information and belief, the Obamacare website has been in existence since at least July 2021.
12. Since that time, Johnson has improperly advertised to Texas consumers through the Obamacare website that he may quote policies for insurers with whom he is not appointed, specifically Assurant, Humana, Blue Cross and Blue Shield, and UnitedHealthcare.
13. Johnson has never been appointed with Assurant, Humana, or Blue Cross and Blue Shield in Texas, and has never been authorized to hold himself out as able to act on behalf of Assurant, Humana, or Blue Cross and Blue Shield.
14. Moreover, Johnson was only appointed by an affiliated group of eight UnitedHealthcare insurers for a period of 11 months from January 4, 2022, until those appointments were canceled on November 28, 2022. He did not hold those appointments at all in 2021, the last month of 2022, or at any time during 2023. Johnson was and is not authorized to hold himself out as able to act on behalf of those UnitedHealthcare insurers, except during the 11 months he was indeed appointed with those insurers.
15. Johnson's past and present representations that he can quote policies for all of these insurers has been and is false, deceptive, and misleading.

Refusal to Comply

16. On March 9, 2023, TDI sent Johnson a Notice of Intent to Institute Disciplinary Action as contemplated in TEX. GOV'T CODE § 2001.054(c), which described TDI's allegations and requested that he voluntarily come into compliance with the Texas Insurance Code and Texas Administrative Code by either:

- a. removing the Obamacare website from the internet;
 - b. clearly and conspicuously disclosing on the website that quotes and insurance services are not available to Texas residents; or
 - c. revising the website by changing the domain name, stating the full licensed name of the agency or agents responsible for the website, and removing all references to insurance companies with which the responsible agent or agency is not appointed.
17. On March 22, 2023, Johnson responded to TDI and refused to change any part of the Obamacare website or remove it from the internet.

Legal Allegations

1. Johnson has engaged and is engaging in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).
2. Johnson has engaged and is engaging in an unfair method of competition or an unfair or deceptive act or practice in the business of insurance in violation of TEX. INS. CODE § 541.003 and 541.052, by making, publishing, disseminating, circulating, or placing before the public an advertisement, announcement, or statement containing an untrue, deceptive, or misleading assertion, representation, or statement regarding the business of insurance.
3. Johnson uses an insurance advertisement that is not truthful and is misleading either in fact or in implication, in violation of 28 TEX. ADMIN. CODE § 21.103(a).
4. Johnson uses an insurance advertisement which because of words, phrases, statements, or illustrations therein or information omitted therefrom, has the capacity and tendency to mislead or deceive purchasers or prospective purchasers, in violation of 28 TEX. ADMIN. CODE § 21.103(d).
5. Johnson fails to identify the person or entity responsible for the insurance advertisement, in violation of 28 TEX. ADMIN. CODE § 21.104(a).

6. Johnson's insurance advertisement used a combination of words or symbols which by their phraseology, shape, color, or other characteristics are so similar to combinations of words, symbols, or physical material normally or usually used by agencies of the federal government or of this state, or that otherwise appear to be of such a nature that the advertisement or solicitation has the capacity or tendency to confuse or mislead prospective insureds into believing that such advertisement or solicitation is connected with an agency of the municipal, state, or federal government, in violation of 28 TEX. ADMIN. CODE §§ 21.103 and 21.104(c).
7. Johnson uses a trade name, name of the parent company of the insurer, or symbol of an insurer without disclosing the name of the actual insurer which has the capacity and tendency to mislead or deceive a prospective purchaser as to the true identity of the insurer, or its relation with public or private institutions, in violation of 28 TEX. ADMIN. CODE § 21.104(b).
8. Johnson is not appointed with the insurers he claims that he has authority to act for, and has been advertising and soliciting using those insurers' names for more than 30 days, in violation of TEX. INS. CODE §§ 4001.051(b)(3) and 4001.201-4001.202.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

1. revoking Byron Anthony Johnson's license;
2. ordering Byron Anthony Johnson to cease and desist from advertising to Texas residents through [REDACTED];
3. directing Byron Anthony Johnson to pay an administrative penalty of up to \$25,000 per violation, under TEX. INS. CODE §§ 84.021 – 84.022; and
4. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
