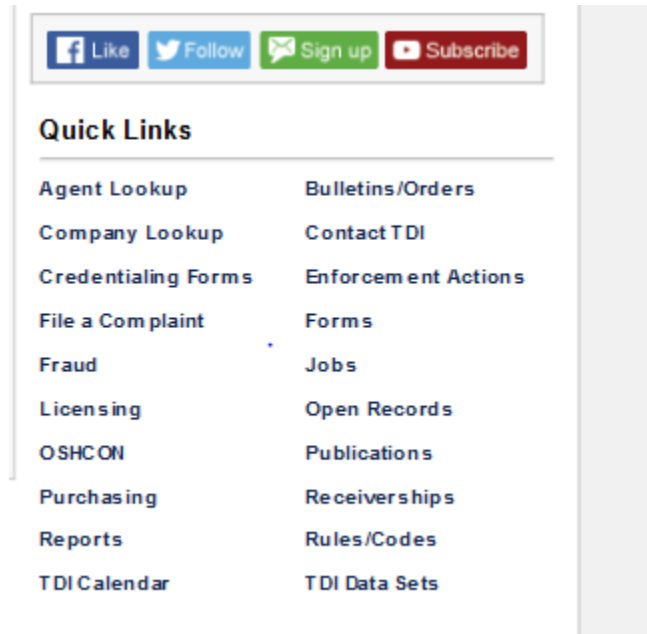


Download Company List Instructions

1. Go to the Texas Department of Insurance Website; <http://www.tdi.texas.gov/>.
2. Under the Quick Links heading on the right side of the page, click on the [Licensing](#) button.



3. Under the Company Licensing and Registration heading, click on the third bullet, "[Companies Regulated by the Texas Department of Insurance.](#)"

Company Licensing and Registration

- Incorporates, licenses, and registers insurance companies, and other ancillary operations for both the [admitted/authorized market](#) and the [registered/non-admitted](#). This office performs many related functions, such as licensing premium finance companies and third party administrators, determining eligibility of surplus lines carriers, registering risk retention groups, accredited / trustee reinsurers and purchasing groups, and licensing life settlement providers and brokers.

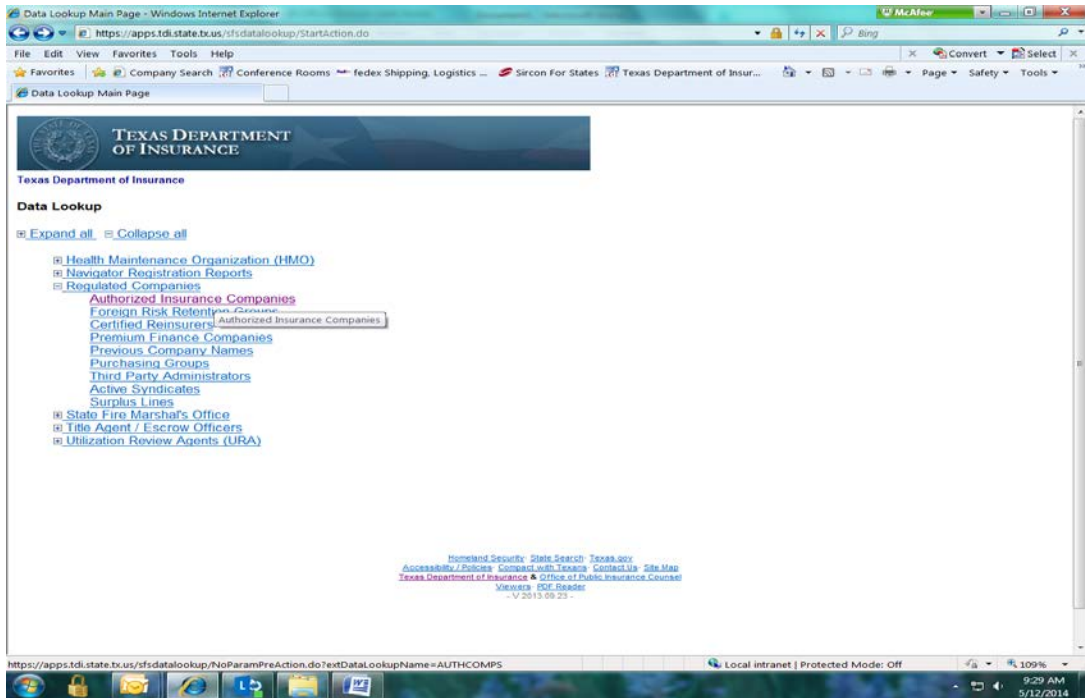
5. Click on the “Regulated Companies” tab
