Texas Department of Insurance (TDI) Senate Business and Commerce Committee Hearing January 23, 2018

Interim Charge

Monitor the implementation of legislation addressed by the Senate Committee on Business and Commerce during the 85th Legislature, Regular Session, including: the settlement of out-of-network health benefit claims involving balance billing and patient's explanation of benefits statements; and make recommendations regarding any additional legislation needed to improve, enhance, and/or complete implementation.

Mediation

Mediation, found in Chapter 1467 of the Insurance Code, mitigates the impact of balance billing by creating a process to resolve payment disputes. With SB 507, mandatory mediation has been extended to now cover commercial PPO and non-HMO state and public school employees in circumstances where services are rendered by an out-of-network facility-based provider in an in-network facility or where the claim is for emergency services at any facility.

- SB 507 is effective for services or supplies provided on or after January 1, 2018.
- Mediation is initiated on consumer request, and both the insurer and provider must participate.
- TDI began accepting mediation requests in 2010 and has seen a gradual increase over time as
 more consumers and providers become aware of the program and as the scope of the statute has
 expanded.
- Most mediation requests are settled informally and do not proceed to actual mediation.
- Since 2010, a total of twelve requests have gone to actual mediation. No requests have gone through the entire process all the way to a trial before a special judge.
