#### Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The door assembly is secured to the wall framing using minimum No.  $10 \times 3$ " screws. Along the side jambs, locate the screws approximately 10" from each corner and spaced 25" on center. Along the head, locate the screws approximately 8" from each corner and spaced 21" on center. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

**Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
