#### Installation:

**Systems 1-2**: The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing through the nailing fin. The nailing fin is secured to the wall framing with 2" long smooth shank galvanized roofing nails. Locate the nails approximately 7" from each corner and 7" on center along the perimeter. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

**System 3:** The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing through the nailing fin. The nailing fin is secured to the wall framing with 2" long smooth shank galvanized roofing nails. Locate the nails approximately 7" from each corner and 7" on center along the perimeter. In addition, the frame of the window is secured to the wall framing with No. 10 x 3" PFH screws. Locate the screws approximately 15"-18" from each corner and 15"-18" on center along the perimeter. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

**Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
