- Continuing education refers to ongoing learning and training that individuals pursue after obtaining their license.
- Continuing education is a condition of licensure for most licensees to ensure they are up to date with the latest industry standards, knowledge, and practices.
- Protects the public and preserves and improves the competence of license holders.
- Insurance Code [4004.053](#) and [2652.058](#).

TDI | CE requirements

- Major lines licenses
 - 24 hours total.
 - 3 hours of ethics.
 - Other agent licenses
 - 10 hours total.
 - 3 hours of ethics.
 - Escrow officers
 - 10 hours total.
 - 2 hours of ethics.
- CE hour requirements.
 - Self-study can only be half of your hours.
 - Other half must be classroom or classroom equivalent.
 - First term is generally prorated. One credit per month of licensure.
 - Use [Sircon](#) account or public transcript to keep up with your requirements and search for courses.
 - Can't repeat courses.

TDI | Other qualifying credits

- Licensees can also obtain credit from sources outside of TDI approved courses.
 - College, law school, or university classroom insurance courses.
 - National Designation Certifications Program credit.
 - CLE/CPE credit: approved insurance related courses from the Texas State Bar or Board of Public Accountancy.
 - Federal Farm Credit Insurance Corporation.
 - Instructor preparation for certified course.
- Limited to above scenarios only.

TDI | Qualifying credit

- Submit request for qualifying credit by submitting either the [FIN522](#) or [FINT22](#).
- Attach supporting documentation and send to CE@tdi.texas.gov.
- Hours granted could count toward your self-study limit, so always check your transcript to see how the hours counted.

TDI | Association credit

- Licensees who currently hold a national designation certification, or are members in good standing of a state or national insurance association, may receive self-study continuing education credit.
 - Reviewing educational materials from the association.
 - Attendance of a conference for the association.
- Submit the [FIN523](#).
- Can obtain up to four hours self-study hours total.
- Check your transcript to confirm processing.

TDI | CE permanent exemption

- Licensees licensed for 20 continuous years in Texas.
- Maintained CE compliance.
- Renewal application still required.
- Submit request via [Sircon.com](https://www.sircon.com) or by completing the [FIN517](#).
- Only for agents/adjusters.

TDI | CE Extension

- Under limited circumstances, licensees can be granted additional time to complete their CE hours.
- Circumstances must be out of the licensee's control (cannot be business or financial reasons).
- Does not extend your expiration date of your actual license.
- Submit request via [Sircon.com](https://www.sircon.com) or by completing the [FIN517](#) and attach supporting documentation.
- Also use this form to appeal a CE fine.

TDI | Renewing your license

- Individual licenses expire the last day of birth month, every other year.
- Renewal requirements:
 - Pay renewal fee.
 - Complete CE requirement.
- Must complete both or license will not renew.
- Licensees only have 90 days to become compliant or a new application will be required.
- Must be re-fingerprinted due to gap in licensure and counter starts over for CE permanent exemption.

- General courses will count for all license types (except escrow).
- CE providers have 30 days to report hours per Texas Administrative Code.
- If you fail to complete required hours on time, you will owe a \$50 per hour fine (up to \$500 max).

TDI | Online CE fine payments

- Invoice payments for CE auto fines should be submitted online.
- [Sircon free account](#) required.
- Must know the invoice ID and license number of the licensee.
- Payments are instantly processed, saving 7-10 days compared to mail.
- No refunds of CE fine payments.

TDI | Product specific training

- Certain insurance products require specific training before you are qualified to sell these products:
 - Annuity.
 - Medicare.
 - Long-term care.
 - Small employer health benefit.
- Each has ongoing CE requirements to maintain compliance.

- Initial 4-hour certification course, which can be found by searching for “Annuity Best Interest 4” course category.
- Ongoing 8-hour CE requirement, per license term, which can be found by searching for “CE-annuity” course category.
- Courses count toward your general CE requirement.
- CE requirement is eligible for permanent exemption (not certification).

TDI | Medicare related

- Initial 8-hour certification course, which can be found by searching for “Cert-Medicare Related” course category.
- Ongoing 4-hour requirement, per license term, which can be found by searching for “CE-Medicare Related” course category.
- Courses count toward your general CE requirement.
- Neither requirement is eligible for permanent exemption.

TDI | Long-term care

- Initial 8-hour certification course, which can be found by searching for “Cert-LTC Partnership” course category.
- Ongoing 4-hour requirement, per license term, which can be found by searching for “CE-LTC Partnership” course category.
- Courses count toward your general CE requirement.
- Neither requirement is eligible for permanent exemption.

TDI | Small employer health benefit plans

- Initial 8-hour certification course, which can be found by searching for “Cert-Small Employer Health” course category.
- Ongoing 4-hour requirement, per license term.
 - Course can be found by searching for “CE-Small Empl Health” course category.
- Courses count toward your general CE requirement.
- Neither requirement is eligible for permanent exemption.

TDI | Surrendering a license

- A surrender of licensure does not cancel or eliminate CE requirements.
- CE is tied to the duration of your licensure, meaning it is accrued every month an individual is actively licensed.
- May be subject to CE fines or other compliance requirements for future license applications.

TDI | Surrendering a license

- How can I surrender my license without owing CE?
 - If you surrender within 6 months of your new license term, CE is not required.
 - If you hold a CE permanent exemption.
 - If you moved out of the state of Texas during your license term.
 - If you are approved for a CE waiver through our appeal process.
- Otherwise, you will receive confirmation of the license surrender and notification of any CE owed from our team at time of processing.

- TDI cannot issue any new licenses, unless CE compliant on all previous licenses.
- Easiest way to be compliant- complete required hours before your license expires.
- If submitting qualifying or association credit, do so well before your license expires.
- If noncompliant, pay the fine and complete deficient CE hours.
- Use the website for relevant links to transcript, courses, and fine payments.
