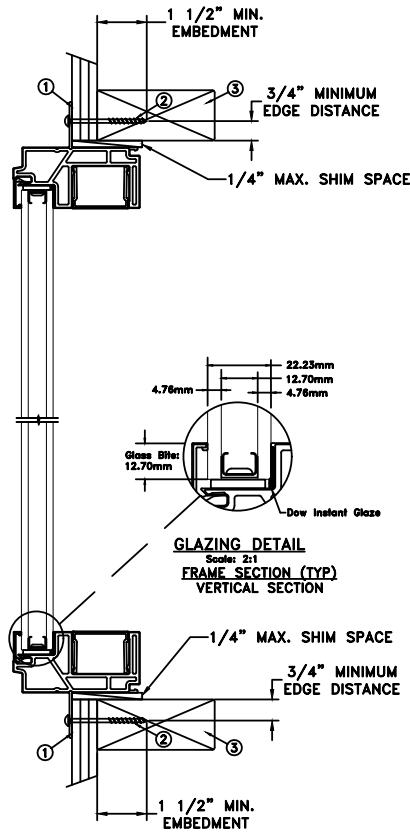
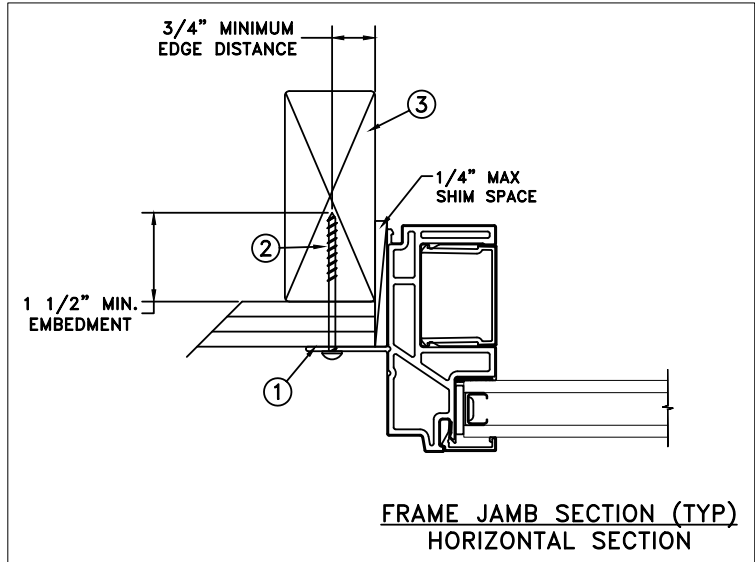


TYPICAL ELEVATION WITH FASTENER SPACING

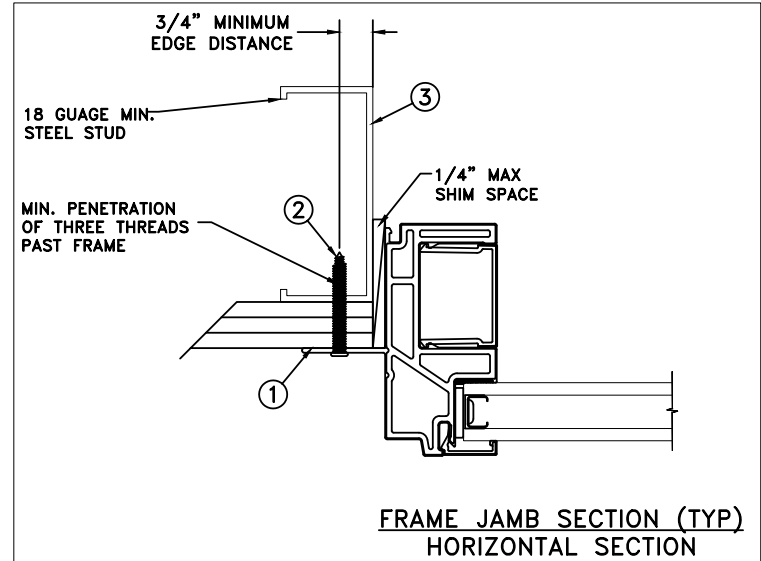


TYPICAL ELEVATION WITH FASTENER SPACING

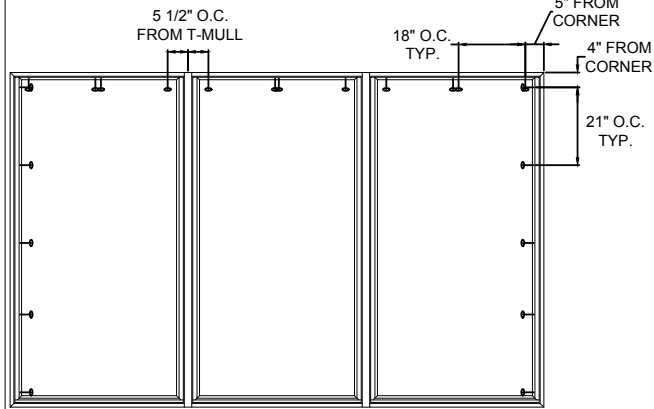

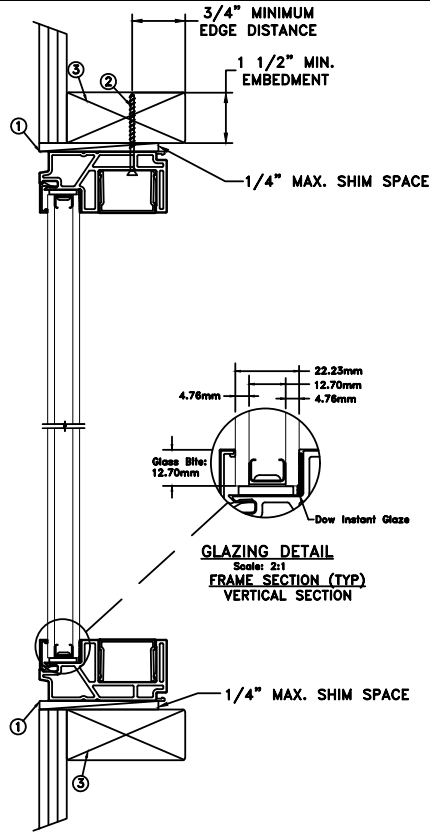

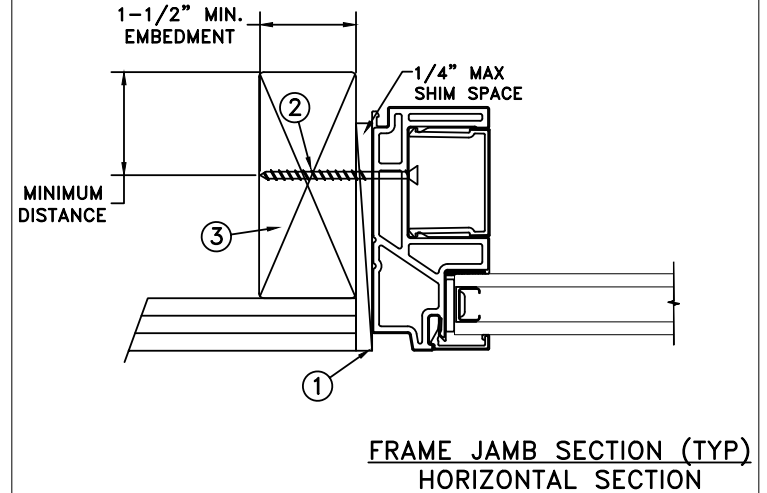


TYPICAL ELEVATION WITH FASTENER SPACING

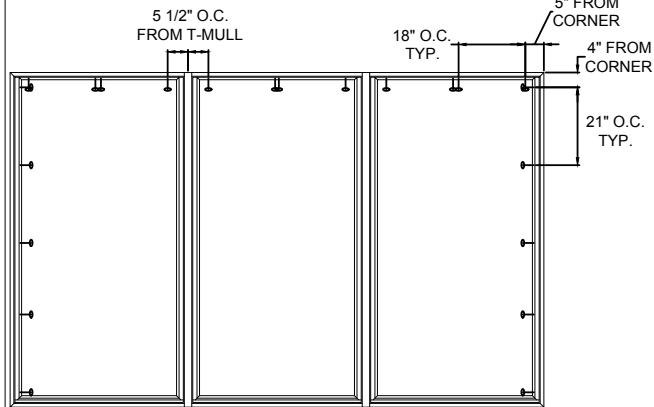

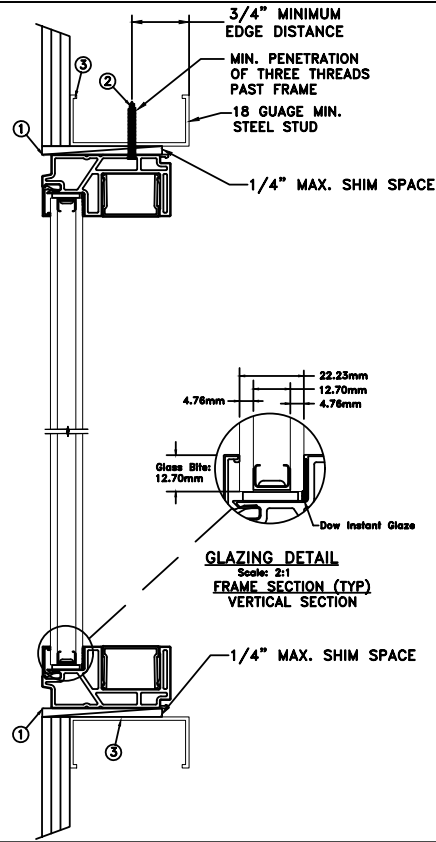

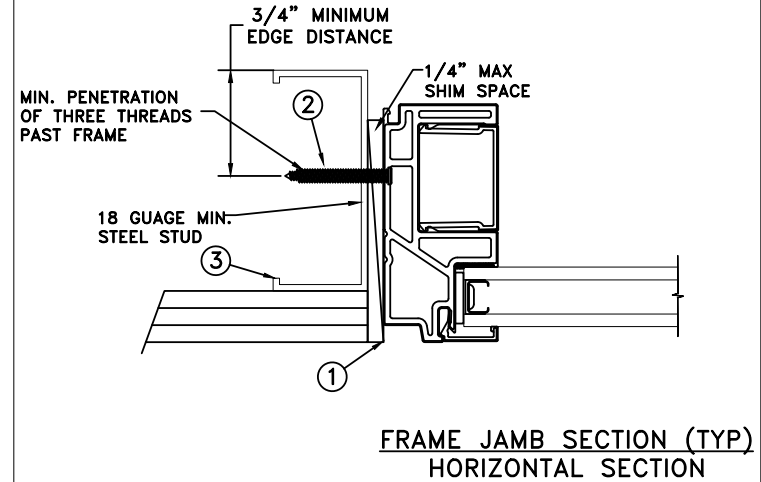


TYPICAL ELEVATION WITH FASTENER SPACING

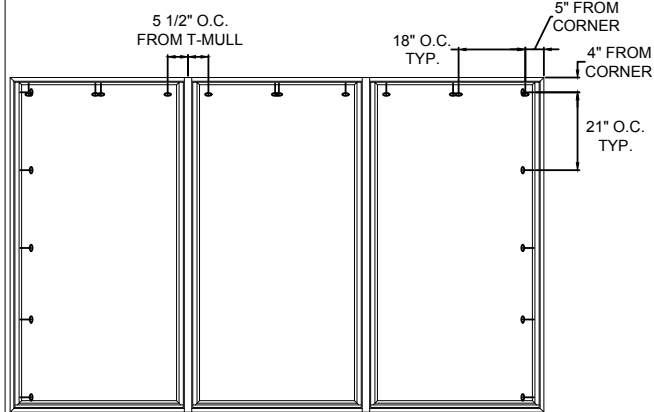

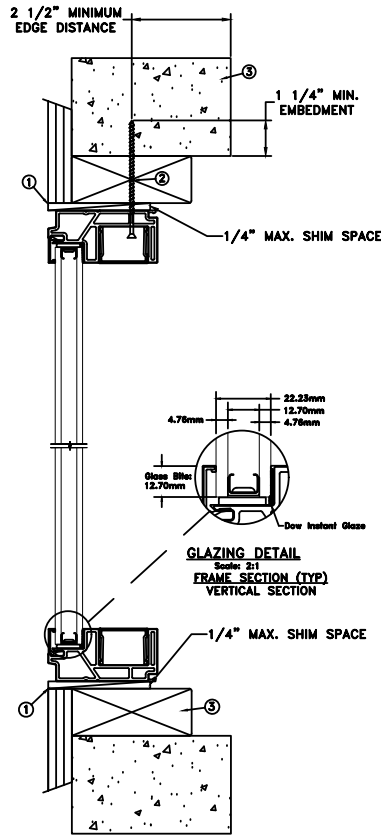

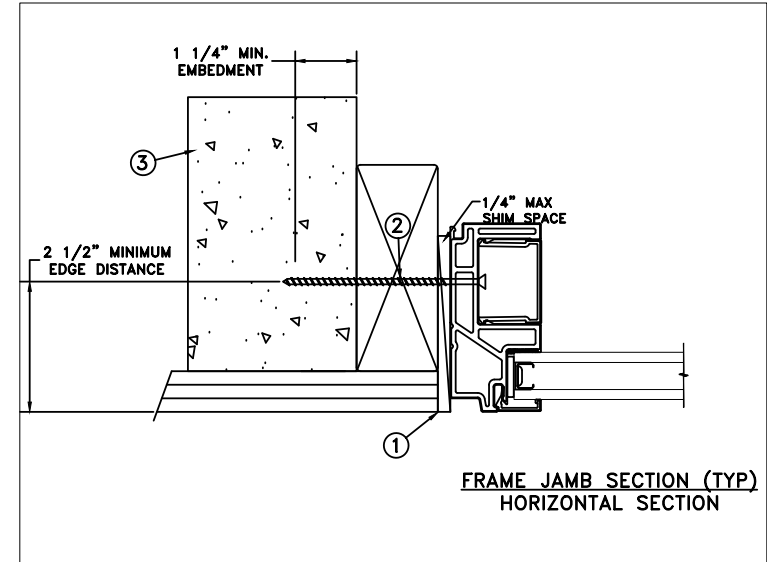


TYPICAL ELEVATION WITH FASTENER SPACING

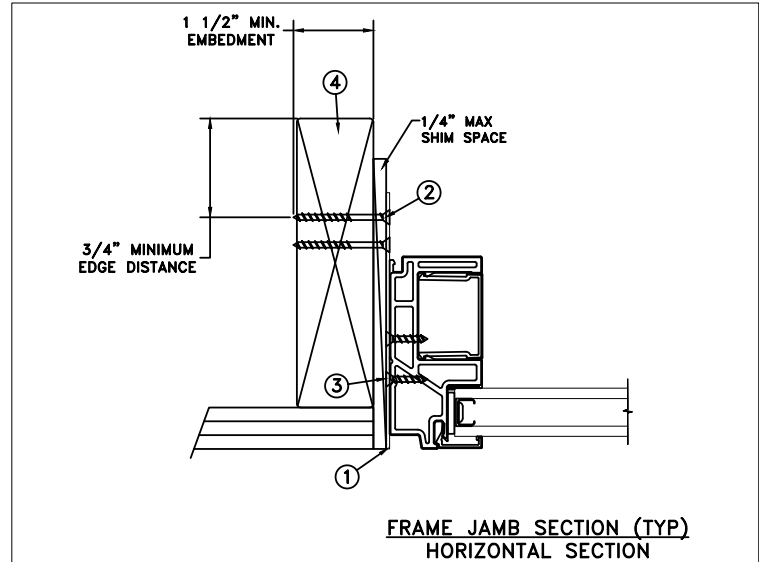

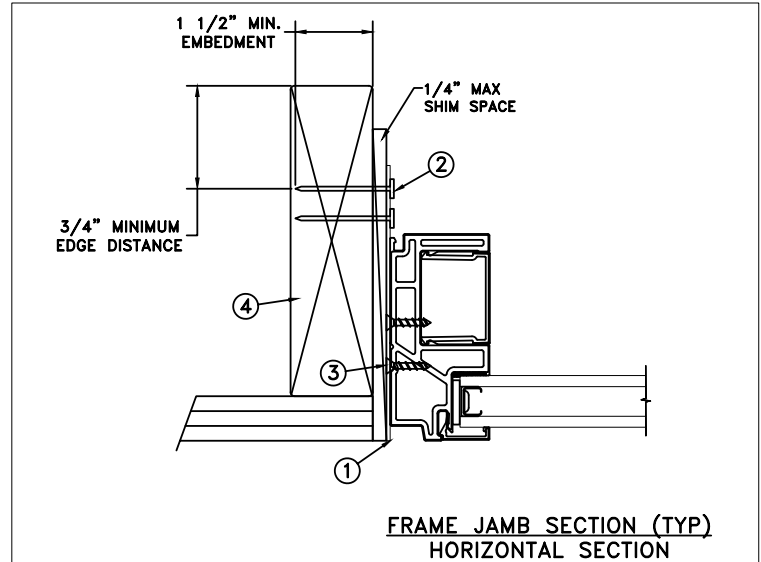

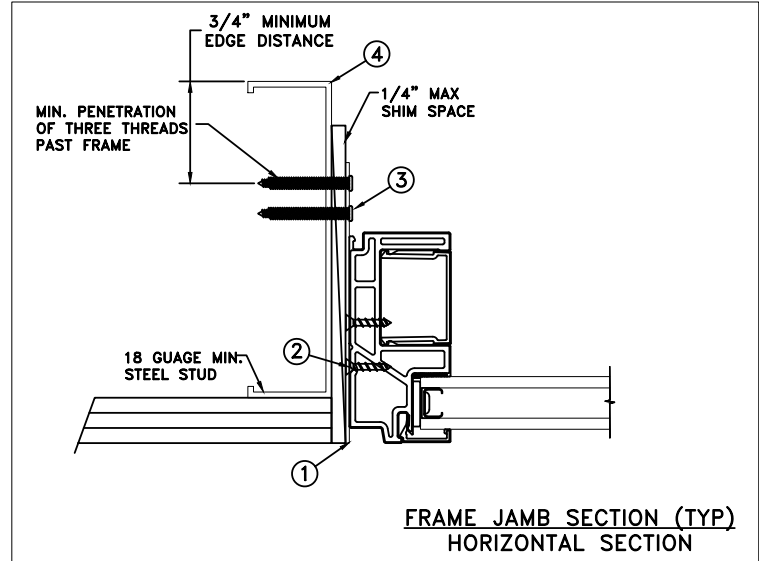

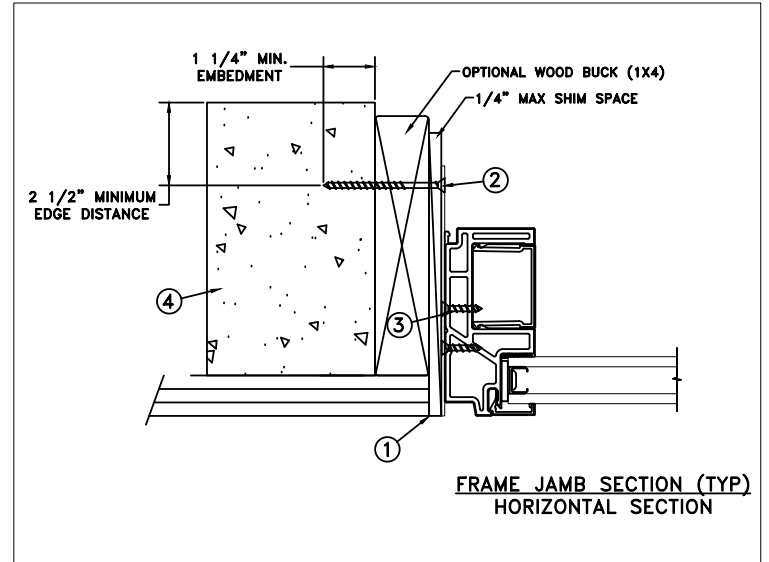
# MASONRY STRAP CONCRETE SCREW INSTALLATION

### Installation Notes:

1. Seal flange/frame to substrate. Sill shall be set on a continuous serpentine bead of structural grade silicone caulk when no fastener is used to anchor the sill (typical).
2. Use 1 - 3/16" Tapcon or equivalent fasteners through masonry strap with sufficient length to penetrate a minimum of 1 1/4" into the buck or concrete. For 2x wood frame substrate (min. S.G. = 0.42). For concrete (min. fc = 3000 psi) or masonry substrate (CMU shall be ASTM C90).
3. Use 2 - #8 PFH or larger fasteners through masonry strap into jamb without penetrating through the jamb into product causing visibility or collateral damage to product.
4. Host structure (wood buck, masonry, steel) to be designed and anchored to properly transfer all loads to the structure. The host structure is the responsibility of the architect or engineer of record for the project of installation.

### General Notes:

1. The product shown herein is designed, tested and manufactured to comply with the wind load criteria of the 2018 International Residential Code (IRC) and 2018 International Building Code (IBC).
2. All glazing shall conform to ASTM E1300.
3. At minimum, glazing is 4.76 mm annealed - 12.70 mm airspace - 4.76 mm annealed glass.
4. Use structural or composite shims where required.
5. Masonry strap specification: 20 Ga. galvanized steel, .096" min. thickness x 1.5" width x 6" length.

This schedule addresses only the fasteners required to anchor the unit to achieve the rated design pressure and impact performance (where applicable) up to the size limitations noted. It is not intended as a guide to the installation process and does not address the sealing consideration that may arise in different wall conditions.
