Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The door assembly is secured to the wall framing with No. 8 x 3" flat head screws. Locate the screws along the head and side jambs approximately 3" from each corner and 12" on center. Use two (2) screws through each hinge leaf. The sill was secured to the wall framing with polyurethane. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
