## **Installation:**

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The door assembly is secured to the wall framing with minimum No.  $9 \times 3$ " wood screws. Along the head and sill, locate the screws approximately 4" from each corner and 12" on center thereafter. Along the side jambs, locate the screws approximately 12" from each corner and on center, and through the top and bottom mounting holes of the hinges. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

**Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
