Installation:

Option 1: The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The door assembly is secured to the wall framing with No. 8 x 3" screws. Locate the screws approximately 6" from each corner and 12" on center along the head and side jambs. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Option 2: The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The door assembly is secured to the wall framing with galvanized steel structural brackets (1-9/16" x 6-1/2" x 0.05"). Secure the brackets to the door frame with two (2) No. 8 x 5/8" screws and to the wall framing with four (4) No. 8 screws. Locate the brackets approximately 6" from each corner and 15" on center. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
