- **Hinges:** Four (4) required; secure to the door with four (4) No. 8 x 1" flat head screws and to the jamb with two (2) No. 9 x 1" and two (2) No. 9 x 3" flat head screws
- **3-point Lockset:** One required; secured with nine (9) No. 8 x 3" wood screws
- Strike plate: Four required; secure with two (2) No. 9 x 3" wood screws
- Speak Easy latch: One required per leaf
 Speak Easy Keeper: One required per leaf
 Speak Easy Hinge: Two required per leaf

Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The door assembly is secured to the wall framing with No. 9 x 3" wood screws. Along the side jambs, locate the screws approximately 12" from each corner and on enter, and through the top and bottom mounting holes of the hinges. Along the head and threshold, locate the screws approximately 4" from the corners and 12" on center thereafter. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
