Schlage handle set: Located on the door panel.

Latch Strike Plate: One (1) required; locate on door frame lock jamb; secured with two (2) No. 8 x 2-1/2" PFH screws.

Lock Strike Plate: One (1) required; located on the door frame lock jamb; secured with two (2) No. 8 x 2-1/2" PFH screws.

Hinges: 4x4 Hagar Butt hinges; Four (4) required; secured to the door slab with four (4) No. 12 x 3/4" PH screws; secured to the door jamb with three (3) No. 12 x 1-1/4" PH screws and one (1) No. 12 x 2-1/2" PH screw (long enough to penetrate a minimum of 1/1/2"into the wall framing).

Sill: Slope sill; Extruded aluminum sill and wood threshold; 1.625" height

Installation:

The wall framing must be minimum Southern Yellow Pine dimension lumber. The assembly must be secured to the wall framing using the vinyl nailing flange with minimum No. 8 PPH screws. The fasteners are located approximately 2" to 5" from each corner and 6" to 8" on center along the

head, sill, and each side jamb. All fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
