### **Impact Resistance:**

1	Yes	These products satisfy TDI's criteria for protection from windborne debris. Install the assemblies at a height on the structure that does not exceed the design pressure rating for the assemblies.

#### Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing with Andersen stainless steel installation clips. (1-1/2" x 6-3/8" x 0.024"). Secure the clips to the window frame with two (2) No. 6 x 3/4" screws and to the wall framing with two (2) No. 6 screws. Along the head and sill, locate the clips approximately 8" from each corner and one (1) at the midspan. Locate the screws along the side jambs approximately 8" from each corner, 3" above and below the midspan, and 20" (max.) on center. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

**Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
