Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing though a nailing fin. The nailing fin is secured to the wall framing with No. 6 steel fasteners. Locate the fasteners beginning at each corner and 9" on center. Along the side jambs, locate one (1) No. 8 x 3 steel fastener through each tie bar guide at the top hole. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
