1-2	Yes	These products satisfy TDI's criteria for protection from windborne debris. Install the assemblies at a height on the structure that does not exceed the design pressure rating for the assemblies.

Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing using steel installation straps (1-1/4" x 9" x 0.030"). Secure the straps to the window frame with two No. 8 screws and to the wall framing using two minimum 11-gauge, 2" long roofing nails. Locate the straps approximately 6" from each corner and 24" on center along the side jambs, and 6" from each corner along the head and sill. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
