Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing using steel installation straps (1-1/4" x 9" x 0.030"). Secure the straps to the window frame using two No. 8 screws and to the wall framing using 1-1/2" long, minimum 11-gauge, smooth shank roofing nails. Locate the straps approximately 6" from each corner and at the midspan along the head and sill, and 6" from each corner and spaced 22" on center along each side jamb. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
