Installation:

Option 1:

The wood wall framing members must be minimum Southern Yellow Pine dimension lumber. The window assembly is secured to the wall framing using galvanized steel installation clips. Clips must be minimum 10-1/16" x 1-5/8" x 0.04". Secure the clips to the window frame using two (2) minimum No. 7 x 5/8" screws and to the wall framing using one (1) minimum No. 8 x 1-3/4" screw. Locate the clips approximately 16-13/16" from each corner and on center along the side jambs and 12" from each corner and on center along the head and sill. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Option 2:

The wood wall framing members must be minimum Southern Yellow Pine dimension lumber. The window assembly is secured to the wall framing using minimum No. $10 \times 2-1/2$ " PFH screws. Locate the screws approximately 10-1/2" from each corner and on center along the side jambs and 8-9/16" from each corner and on center along the head and sill. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC, the IBC, and the Texas Revisions.
