Impact Resistance:

1	Yes	These products have been tested for windborne debris resistance. Install the assemblies at a height on the structure that does not exceed the design pressure rating for the assemblies.

Installation:

The wood wall framing members must be minimum Southern Yellow Pine dimension lumber using the integral nailing fin at the head, sill, and side jambs of the window frame. Secure the nailing fin to the wall framing with minimum No. 8 PPH screws. Locate the fasteners approximately 2" from each corner and approximately 4" on center. In addition, installation clips (galvanized steel, 20-gauge, 5"-8" long x 1-1/2" wide) are required. At the picture window head, a clip is required approximately 22" from each corner. A clip is also required approximately 3" on each side of the horizontal mull location between the picture window and the awning window. The installation clips are secured to the window frame with three No. 6 x 5/8" PFH screws and are secured to the wall framing with two No. 8 PPH screws. Locate one clip at the sill of the mull post between the awning windows. The installation clip is secured to the mull post with two No. 8 x 2-1/2" PH SS screws and are secured to the wall framing with two No. 8 PPH screws. For two-wide units, installation clips are required approximately 3" on each side of the mull at the head and the sill. Use fasteners long enough to penetrate a minimum of 1-1/2" into the wall framing.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
