Installation:

System 1: The wood wall framing members must be minimum Southern Yellow Pine dimension lumber. The window assembly is secured to the wall framing using an integral vinyl nailing fin secured to the wall framing with minimum No. 8 PPH screws. Locate the screws approximately 2"-4" from each corner and 7" on center along the perimeter. Locate one galvanized steel, 20-gauge x 1-1/2" x 5", anchor strap 3" on each side of the mull centerline at each mull end. Secure the straps to the window frame with three (3) No. 8 x 5/8" PFH self-tapping screws and to the wall framing with two (2) No. 8 PPH screws. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

System 2: The wood wall framing members must be minimum Southern Yellow Pine dimension lumber. The window assembly is secured to the wall framing using an integral vinyl nailing fin secured to the wall framing with minimum No. 8 PPH screws. Locate the screws approximately 2"-4" from each corner and 7" on center along the perimeter. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
