General remarks and official action taken:

The commissioner of insurance considers whether disciplinary action should be taken against Robert Keith Taylor.

Waiver

Taylor acknowledges that the Texas Insurance Code and other applicable law provide certain rights relating to the subject matter of any disciplinary proceeding and how it is conducted. Taylor waives all of these rights in consideration of the entry of this consent order.


Findings of Fact

1. Robert Keith Taylor, individual identification number 480421, holds an adjuster license.
2. On January 8, 2015, in Case No. 4:13-cr-00052-002 in the United States District Court, Southern District of Iowa, Robert Keith Taylor was convicted of the federal felony offenses of false statement to a bank and wire fraud and sentenced to 28 months of confinement to be served concurrently on each count and five years of supervised release after he is released from confinement. Robert Keith Taylor was ordered, jointly and severally along with his co-conspirator, to pay \$623,924.72 in restitution to American International Group and to individually pay \$376,468.80 in restitution to Bank of America.
3. Robert Keith Taylor was incarcerated on April 15, 2015.

Conclusions of Law

1. The commissioner has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051, 82.052, 4005.101, and 4005.102; TEX. OCC. CODE §§ 53.021- 53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. TEX. GOV'T CODE § 2001.056, TEX. INS. CODE ANN. § 82.055, and 28 TEX. ADMIN. CODE § 1.47 give the commissioner authority to informally dispose of this case.
3. The commissioner may take disciplinary action against Robert Keith Taylor because:
 - a. He has been convicted of a felony, as contemplated by TEX. INS. CODE § 4005.101(b)(8), TEX. OCC. CODE §§ 53.021 – 53.023, and 28 TEX. ADMIN. CODE § 1.502;
 - b. His license was revoked by operation of law following incarceration for a felony conviction, as contemplated by TEX. OCC. CODE § 53.021(b); and
 - c. He does not have consent from the commissioner of insurance to engage in the business of insurance in Texas following a felony conviction, as required by 18 U.S.C.A. § 1033.

The commissioner orders that Robert Keith Taylor's adjuster license is revoked by operation of law.


