General remarks and official action taken:

The subject of this order is whether disciplinary action should be taken against Brittany Ouellette.

FINDINGS OF FACT

1. Brittany Ouellette, individual identification number 1542736, holds a non-resident general lines agent license with a life, accident, and health qualification, originally issued by TDI on December 14, 2015.
2. On November 6, 2017, the department sent a notice of hearing to Ouellette's last known address provided in writing to the department, 2909 N. 118th St., Fl. 3, Omaha, Nebraska 68164, and one additional address: 15030 Giles Rd., Apt. 307, Omaha, Nebraska 68138.
3. Ouellette failed to file a written response to the notice of hearing within 20 days of the date the notice of hearing was mailed.
4. Ouellette has a non-resident license because she lives in Nebraska. This license type requires that Ouellette have a resident license in good standing in her home state.
5. On November 23, 2016, the Nebraska Department of Insurance revoked Ouellette's resident insurance agent license. Ouellette did not notify TDI of the revocation.
6. California, Idaho, Kansas, Louisiana, Mississippi, North Dakota, South Dakota, Virginia, Vermont, and Wyoming also took administrative action against Ouellette. Ouellette did not notify TDI of those administrative actions.

CONCLUSIONS OF LAW

1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.252, 4005.101, 4005.102, 4054.051, and 4056.052, and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89 give the commissioner authority to dispose of this case informally.
3. Based on 28 TEX. ADMIN. CODE § 19.906, Ouellette's last known address is presumed to be 2909 N. 118th St., Fl. 3, Omaha, Nebraska 68164.
4. The department sent a notice of hearing to Ouellette's last known address, as required by 28 TEX. ADMIN. CODE §§ 1.28(c) and 1.88(c), 1 TEX. ADMIN. CODE § 155.401, and TEX. GOV'T CODE Ch. 2001. The department also sent a notice of hearing to one additional address: 15030 Giles Rd., Apt. 307, Omaha, Nebraska 68138.
5. The department's allegations in the notice of hearing, set out herein as findings of fact nos. 1 and 4-6, are deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.
6. Ouellette does not hold a license in good standing as an agent in her state of residence, as required by TEX. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
7. Ouellette did not notify the department of the administrative actions taken against her, in violation of TEX. INS. CODE § 4001.252.

It is ordered that Brittany Ouellette's non-resident general lines agent license with a life, accident, and health qualification is revoked.
