**General remarks and official action taken:**

This is a default order taken against Gregory Charles Diedrich (Respondent) because he does not hold a license in good standing as an agent in his home state of residence and did not notify the Texas Department of Insurance of the administrative action taken against him. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

**Findings of Fact**

1. On June 9, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, 500 N. Rainbow Blvd., Suite 300, Las Vegas, NV 89107-1061.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

## Conclusions of Law

1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101, and 4056.052; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.

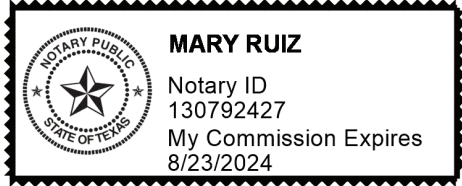

**ORIGINAL PETITION**

The Texas Department of Insurance seeks to take disciplinary action against Gregory Charles Diedrich. In support of this petition, the department makes the following allegations upon information and belief:

**Jurisdiction**

The Commissioner of Insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4056.053, and TEX. GOV'T CODE §§ 2001.051-2001.178.

1. Gregory Charles Diedrich (Diedrich), individual identification number 2254823, holds a non-resident general lines agent license with a qualification in life, accident, health, and HMO, originally issued by the Texas Department of Insurance on September 9, 2020.
2. Diedrich has a Texas non-resident license because Diedrich lives in Nevada. A non-resident license requires that the holder have a resident license in good standing in the home state.
3. Diedrich surrendered his license in a *Stipulated Consent Agreement and Order* on March 9, 2021, in Cause No. 20.0105. Diedrich failed to notify TDI of his change in license status.

**B**

**Legal Allegations**

1. Diedrich no longer holds a home state license in good standing, as required by TEX. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
2. Diedrich did not notify TDI of the administrative action taken against him, in violation of TEX. INS. CODE § 4001.252.

**Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

1. revoking Diedrich's license and
2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.

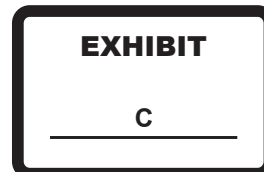
