#### General remarks and official action taken:

The subject of this default order is whether a general lines agent license should be issued to Lisa Ann Maxwell (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

### **Findings of Fact**

## Failure to Respond to Notice of Hearing

- 1. On May 12, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the departmen

- T., New Caney, Texas 77357. The Notice of Hearing and Original Petition was also sent by electronic mail to an address associated with Respondent.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

### **Conclusions of Law**

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. Admin. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

### ORIGINAL PETITION

The Texas Department of Insurance seeks to deny Lisa Ann Maxwell's license application. In support of this petition, the department makes the following allegations upon information and belief:

## Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051; 28 Tex. ADMIN. Code § 1.502; Tex. Occ. Code § 53.021-53.023; and Tex. Gov't Code §§ 2001.051-2001.178.

# **Factual Allegations**

# License Application

- 1. Lisa Ann Maxwell (Maxwell) applied for a general lines agent license with a property & casualty qualification on December 30, 2020.
- 2. The department proposed to deny her application on May 17, 2021. Maxwell appealed the decision and made a written request for a hearing.

# Criminal History

3. On November 9, 1982, Maxwell committed misdemeanor Harassing Communication. She was convicted on April 7, 1983, in the County Criminal Court

- at Law No. 9 of Harris County, Texas in Cause No. 682472, and was sentenced to 10 days confinement and a fine of \$150.
- 4. On August 27, 1987, Maxwell committed misdemeanor Public Lewdness. She was convicted on February 1, 1988, in the County Criminal Court at Law No. 4 of Harris County, Texas in Cause No. 962632, and was sentenced to three days confinement.
- 5. On December 10, 1990, Maxwell committed misdemeanor Theft. She was convicted on December 12, 2990, in the County Criminal Court at Law No. 4 of Harris County, Texas in Cause No. 9048302, and was sentenced to 45 days confinement.
- 6. Between November 28, 1992, and December 12, 1992, Maxwell committed felony Attempted Aggravated Burglary. She was convicted on April 5, 1993, in the 30th Judicial District Criminal Court of Shelby County, Tennessee in Cause No. 93-01756, and was sentenced to two years in a workhouse and a fine of \$500.
- 7. On January 1, 1997, Maxwell committed felony Unlawful Possession of a Controlled Drug With Intent to Distribute and the misdemeanors Soliciting and Resisting an Officer. She was convicted of all three offenses on February 10, 1997, in the District Court of Tulsa County, Oklahoma in Cause No. CF-1997-00096. She was sentenced to five years confinement for the felony and six months confinement for each of the misdemeanors, all served concurrently.
- 8. On June 20, 2000, Maxwell committed felony Robbery. She received a deferred adjudication on August 25, 2000, in the 204th District Court of Dallas County, Texas in Cause No. F-0050461, and was sentenced to probation for seven years and a fine of \$500. She was later convicted on December 22, 2000, in the same court, and was sentenced to two years confinement, served concurrently with Cause No. F-0052327, and a fine of \$500.
- 9. On August 11, 2000, Maxwell committed felony Burglary of a Building. She received a deferred adjudication on August 25, 2000, in the 204th District Court of Dallas County, Texas in Cause No. F-0052327, and was sentenced to probation for five years and a fine of \$500. She was later convicted on December 22, 2000, in the same court, and was sentenced to one year confinement, served concurrently with Cause No. F-0050461, and a fine of \$500.

- 10. On August 11, 2000, Maxwell committed misdemeanor Evading Arrest. She was convicted on August 28, 2000, in the County Criminal Court No. 1 of Dallas County, Texas in Cause No. MA0057427, and was sentenced to 45 days confinement.
- 11. On November 20, 2000, Maxwell committed felony Unauthorized Use of a Motor Vehicle. She was convicted on December 22, 2000, in the 204th District Court of Dallas County, Texas in Cause No. F-0055998, and was sentenced to one year confinement.
- 12. On November 20, 2000, Maxwell committed misdemeanor Evading Arrest. She was convicted on December 28, 2000, in the County Criminal Court No. 9 of Dallas County, Texas in Cause No. MA0063033, and was sentenced to 150 days confinement and a fine of \$400.
- 13. On December 10, 2002, Maxwell committed felony Possession of Cocaine Less Than One Gram. She was convicted on December 12, 2002, in the 337th District Court of Harris County, Texas in Cause No. 932990, and was sentenced to seven months confinement.
- 14. On October 28, 2003, Maxwell committed felony Possession of Cocaine less than One Gram. She was convicted on September 29, 2003, in the 185th District Court of Harris County, Texas in Cause No. 966293, and was sentenced to nine months confinement.
- 15. On August 10, 2004, Maxwell committed misdemeanor Prostitution. She was convicted on August 13, 2004, in the County Criminal Court at Law No. 5 of Harris County, Texas in Cause No. 1252314, and was sentenced to 10 days confinement.
- 16. On August 16, 2004, Maxwell committed misdemeanor Prostitution. She was convicted on August 18, 2004, in the County Criminal Court at Law No. 9 of Harris County, Texas in Cause No. 1253366, and was sentenced to 30 days confinement.
- 17. On September 7, 2004, Maxwell committed misdemeanor Prostitution 2nd. She was convicted on September 9, 2004, in the County Criminal Court at Law No. 7 of Harris County, Texas in Cause No. 1257392, and was sentenced to 90 days confinement.

- 18. On December 7, 2004, Maxwell committed felony Delivery of a Controlled Substance. She was convicted on December 10, 2004, in the 185th District Court of Harris County, Texas in Cause No. 1009694, and was sentenced to 10 months confinement, to run concurrently with Cause No. 1009695.
- 19. On December 7, 2004, Maxwell committed felony Possession of Cocaine less than One Gram. She was convicted on December 10, 2004, in the 185th District Court of Harris County, Texas in Cause No. 1009695, and was sentenced to 10 months confinement, to run concurrent with Cause No. 1009694.
- 20. On September 15, 2006, Maxwell committed felony Possession of Cocaine less than One Gram. She was convicted on September 18, 2006, in the 178th District Court of Harris County, Texas in Cause No. 1084962, and was sentenced to 90 days confinement.
- 21. On August 12, 2007, Maxwell committed misdemeanor Possession of Drug Paraphernalia. She was convicted on February 8, 2008, in the 16th Judicial District Court Parish of St. Mary, Louisiana in Cause No. 2007-174305, and was placed on probation for one year. Her probation was repealed on February 27, 2008, due to violation of probation.
- 22. On October 9, 2007, Maxwell committed misdemeanors Possession of Drug Paraphernalia and Driving on Right Side of Road. She was convicted on December 11, 2007, in the 16th Judicial District Court Parish of St. Mary, Louisiana in Cause No. 2007-174712, and was sentenced to six months confinement, probated for six months. Her probation was repealed on February 27, 2008, due to violation of probation.
- 23. On December 11, 2008, Maxwell committed felony Prostitution. She was convicted on December 15, 2008, in the 174th District Court of Harris County, Texas in Cause No. 1195086, and was sentenced to 120 days confinement.
- 24. On October 25, 2009, Maxwell committed misdemeanor Driving While Intoxicated. She was convicted on February 10, 2010, in the County Court at Law No. 3 of Galveston County, Texas in Cause No. 298482, and was sentenced to 180 days confinement, probated for 1 year, and a fine of \$200. Her probation was revoked on March 1, 2011, due to her conviction in Cause No. 311637.

- 25. On January 31, 2011, Maxwell committed misdemeanor Criminal Trespass. She was convicted on March 1, 2011, in the County Court at Law No. 3 of Galveston County, Texas in Cause No. 311637, and was sentenced to 180 days confinement.
- 26. On February 17, 2011, Maxwell committed misdemeanor Evading Arrest Detention. She was convicted on March 1, 2011, in the County Court at Law No. 3 of Galveston County, Texas in Cause No. 312288, and was sentenced to 180 days confinement.
- 27. On June 4, 2012, Maxwell committed misdemeanor Prostitution with Previous Convictions. She was convicted on September 13, 2013, in the 10th Judicial District Court of Galveston County, Texas in Cause No. 12-CR-1544, and was sentenced to 30 days confinement.
- 28. On May 17, 2014, Maxwell committed misdemeanor Criminal Trespass. She was convicted on May 28, 2014, in the Criminal County Court at Law No. 1 of Galveston County, Texas in Cause No. MD-0345549, and was sentenced to 14 days confinement.
- 29. On July 9, 2014, Maxwell committed felony Prostitution with 3rd or more. She was convicted on August 29, 2014, in the 10th Judicial District Court of Galveston County, Texas in Cause No. 14-CR-2106, and was sentenced to 90 days confinement.
- 30. On September 3, 2014, Maxwell committed misdemeanor Criminal Trespass. She was convicted on September 4, 2014, in the Criminal County Court at Law No. 2 of Galveston County, Texas in Cause No. MD-0348592, and was sentenced to 16 days confinement.
- 31. On May 28, 2019, Maxwell committed misdemeanor Driving While Intoxicated 2nd. She was convicted on October 10, 2019, in the County Court at Law No. 4 of Montgomery County, Texas in Cause No. 19-341507, and was sentenced to one year confinement, probated for 18 months.

## **Legal Allegations**

- 1. Maxwell committed acts for which a license may be denied pursuant to Tex. INS. CODE § 4005.101, as contemplated by Tex. INS. CODE § 4005.102.
- 2. Maxwell has committed a felony, as contemplated by 28 Tex. ADMIN. CODE § 1.502(d), Tex. Ins. Code § 4005.101(b)(8) and Tex. Occ. Code §§ 53.021-53.025.
- 3. Pursuant to Tex. Occ. Code § 53.021(d)(1)(B)(i) and (d)(2)(A)-(B), the department considers Cause No. 19-341507 to be a conviction.
- 4. Maxwell committed offenses which directly relate to the duties and responsibilities of the licensed occupation, as contemplated by Tex. Occ. Code § 53.021(a)(1) and 28 Tex. Admin. Code § 1.502(e).
- 5. Maxwell committed offenses the department considers to be of such a serious nature that they are of prime importance in determining fitness for licensure, as contemplated by 28 Tex. ADMIN. CODE § 1.502(e)(1), (e)(3), and (4)(D)-(G) and Tex. Occ. Code § 53.025.
- 6. Texas Department of Insurance guidelines, 28 Tex. ADMIN. CODE § 1.502(c)-(e), emphasize the department:
  - a. considers it very important that applicants be honest, trustworthy, and reliable;
  - b. may refuse to issue an original license if the department determines that the applicant has committed a felony or misdemeanor that directly relates to the duties and responsibilities of the licensed occupation;
  - c. considers any offense for which fraud, dishonesty, or deceit is an essential element to be of prime importance when determining fitness for licensure;
  - d. considers any felony involving moral turpitude to be of prime importance when determining fitness for licensure; and
  - e. considers the offenses of Theft, Attempted Aggravated Burglary, Unlawful Possession of a Controlled Drug With Intent to Distribute, Soliciting, Resisting Arrest, Robbery, Burglary of a Building, Prostitution, Delivery of a Controlled

Substance, and Criminal Trespass to be of such a serious nature that they are of prime importance when determining fitness for licensure.

7. Maxwell was convicted of a felony involving dishonesty or breach of trust, as specified in 18 U.S.C. § 1033, and requires written consent from the commissioner of insurance to engage or participate in the business of insurance.

## **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Lisa Ann Maxwell's license application and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law.
