#### General remarks and official action taken:

The subject of this default order is whether an insurance adjuster license should be issued to Rashad Shakur Hallett, Jr. (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance (TDI). This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

#### **Findings of Fact**

# Failure to Respond to Notice of Hearing

- 1. On October 16, 2023, TDI filed a Notice of Hearing, attached as Exhibit A, and a previously filed Original Petition attached as Exhibit B, with the State Office of Administrative Hearings. On the same day, TDI filed an Amended Notice of Hearing, attached as Exhibit C.
- 2. TDI's factual allegations set out in the attached Notice of Hearing, Original Petition, and Amended Notice of Hearing are incorporated in this order as findings of fact.

- 3. On October 16, 2023, TDI sent the Notice of Hearing, Original Petition, and the Amended Notice of Hearing to Respondent's last known address provided in writing to TDI, 314 Tioga Drive, Arlington, TX 76002. These three pleadings were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, and 4101.051; Tex. Occ. Code §§ 53.021-53.023; Tex. Gov't Code §§ 2001.051-2001.178; and 28 Tex. Admin. Code § 1.502.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. TDI provided proper notice of the hearing under Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. Admin. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, TDI is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. TDI's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

#### ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to deny Rashad Shakur Hallett, Jr.'s license application. In support of this petition, TDI makes the following allegations upon information and belief:

#### Jurisdiction

The commissioner of insurance has jurisdiction over this matter under Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4101.051; Tex. Gov't Code §§ 2001.051-2001.178; Tex. Occ. Code §§ 53.021–53.023; and 28 Tex. Admin. Code §§ 1.502.

#### **Factual Allegations**

# **License Application**:

- 1. Rashad Shakur Hallett, Jr. (Hallett) applied for an insurance adjuster license with TDI on or about May 23, 2023. He disclosed his criminal history.
- 2. On or about May 25, 2023, TDI requested Hallett provide copies of his court documents. Hallett complied.
- 3. On or about July 24, 2023, TDI proposed to deny Hallett's license.
- 4. On or about August 17, 2023, Hallett requested a hearing.

5. On or about September 13, 2023, TDI acknowledged receipt of Hallett's request for a hearing.

#### **Criminal History**:

Case no. BUR-21-000907-002

- 6. On or about April 9, 2020, and May 2, 2020, Hallett committed motor vehicle burglary in Burlington County, New Jersey.
- 7. On or about December 2, 2022, in case no. BUR-21-000907-002, the Superior Court of New Jersey, Burlington County convicted Hallett of one count of Third-Degree Felony Burglary Entering Structure, etc. no Bl/unarmed.
- 8. The court sentenced Hallett to three years' probation. His fines and penalties included: \$75 for a safe neighborhood services fund, \$5 for probation supervision, and a \$50 Victims of Crime Compensation Office (VCCO) assessment. He must pay his fines and penalties at the rate of \$25 per month beginning June 1, 2023.

Case no. BUR-20-00299-002

- 9. On or about May 1, 2020, Hallett committed motor vehicle burglary in Burlington County, New Jersey.
- 10. On or about December 2, 2022, in case no. BUR-20-00299-002, Hallett pleaded guilty to, and the Superior Court of New Jersey convicted Hallett of two counts of Third-Degree Burglary Entering Structure, Etc. No Bl/unarmed.
- 11. On or about January 27, 2023, the court sentenced Hallett to three years non-custodial probation. The court ordered him to pay restitution on all nine counts of burglary from the indictment (including those dismissed).

Case no. CAM-20-002520-002

12. On or about May 2, 2020, Hallett committed motor vehicle burglary in Burlington County, New Jersey.

- 13. On or about December 6, 2021, in case no. CAM-20-002520-002, Hallett pleaded guilty to third-degree felony burglary entering structure, etc. no Bl/unarmed.
- 14. On or about October 28, 2022, the Superior Court of Camden County, New Jersey convicted Hallett, sentenced him to three years deferred adjudication with standard conditions of supervision, and ordered him to pay \$3,000 victim restitution at the rate of \$100 per month.
- 15. The court also ordered Hallett to pay additional fees including: \$75 to the Safe Neighborhood fund, \$50 to the VCCO, \$30 to the Law Enforcement Officers' Training and Equipment Fund, and \$5 for probation supervision at the rate of \$20 per month (total payments added up to \$120 per month).
- 16. On or about November 15, 2022, the court rescinded the part of the sentence ordering Hallett to pay only restitution and added special conditions of supervision. They included: completing court ordered substance abuse evaluation and recommended treatment, paying for, and providing a DNA sample, having no contact with the victims, and forfeiting his seized knife.
- 17. On or about January 27, 2023, Hallett's community supervision transferred from New Jersey to the Adult Probation Office of Fort Worth, Texas. Hallett remains on probation until on or about December 12, 2025.

#### **Legal Allegations**

- 1. Hallett engaged in fraudulent or dishonest acts or practices under Tex. INS. CODE § 4005.101(b)(5).
- 2. Hallett has been convicted of a felony as contemplated by Tex. Ins. Code § 4005.101(b)(8), Tex. Occ. Code §§ 53.021-53.023, and 28 Tex. Admin. Code § 1.502.
- 3. Hallett has been convicted of a felony involving moral turpitude or breach of fiduciary duty as contemplated in 28 Tex. ADMIN. CODE § 1.502(f)(3).<sup>2</sup>

- 4. Hallett's offense directly relates to the duties and responsibilities of the licensed occupation, as Tex. Occ. Code § 53.021 and 28 Tex. Admin. Code §1.502(d)(1) contemplate.
- 5. TDI guidelines, 28 Tex. ADMIN. CODE § 1.502(c)-(f), emphasize that TDI:
  - a. considers it very important that applicants be honest, trustworthy, and reliable;
  - b. may refuse to issue an original license if TDI determines that the applicant has committed a felony or misdemeanor, or has engaged in fraudulent or dishonest activity that directly relates to the duties and responsibilities of the licensed occupation; and
  - c. considers burglary to be a crime in which fraud, dishonesty, or deceit is an essential element and to be of such a serious nature that it is of prime importance when determining fitness for licensure, as contemplated in 28 Tex. ADMIN. CODE § 1.502(f)(4)(J).
- 6. The factors listed in 28 Tex. ADMIN. CODE § 1.502(h) do not outweigh the serious nature of Hallett's criminal offenses, as 28 Tex. ADMIN. CODE § 1.502(f) contemplates.
- 7. Hallett has been convicted of a criminal felony involving dishonesty or a breach of trust, as contemplated in 18 U.S.C. § 1033.

#### **Relief Sought**

If one or more of the above allegations is found to be true, TDI asks the Administrative Law Judge to enter a Proposal for Decision recommending that the commissioner of insurance issue an order:

- 1. denying Hallett's license application; and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
