General remarks and official action taken:

This is a default order taken against GloriFi Reciprocal Insurance Exchange (Respondent) because it failed to file an annual report and quarterly financial statements, has not written policies in Texas since its inception, and failed to comply with an order issued by the commissioner. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance (TDI). This order revokes Respondent's certificate of authority.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On November 8, 2023, TDI filed a Notice of Hearing, attached as Exhibit A, together with a previously filed Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. TDI's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. TDI sent the Notice of Hearing and Original Petition together to Respondent's last known address provided in writing to the department, 11700 Preston Rd Ste 600 394, Dallas, Texas 75230.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. INS. CODE §§ 82.051-82.055, 801.051-801.053, 801.057, 942.003, 942.051-942.054, 942.101; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. TDI provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054; and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, TDI is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. TDI's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to take disciplinary action against GloriFi Reciprocal Insurance Exchange's license. In support of this petition, TDI makes the following allegations upon information and belief:

Jurisdiction

The commissioner of insurance has jurisdiction over this matter under Tex. INS. CODE §§ 82.051-82.055, 801.051-801.053, 801.057, 942.003, 942.051-942.054, 942.101, 942.201, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- 1. GloriFi Reciprocal Insurance Exchange (GloriFi) holds a certificate of authority to transact business in the state of Texas that was issued by TDI on December 29, 2021.
- 2. GloriFi is required to file an annual report with TDI not later than March 1 of each year.
- 3. GloriFi is required to file quarterly financial statements with TDI.
- 4. GloriFi failed to file any financial statements with TDI since the first quarter of 2022.
- 5. GloriFi failed to file the annual report with TDI that was due March 1, 2023.

- 6. TDI has attempted to contact GloriFi regarding the delinquent filings but has been unsuccessful.
- 7. GloriFi has not written policies in Texas and has no in-force business since its inception.
- 8. In Official Order No. 2023-8075, entered on July 11, 2023, the commissioner ordered Glorifi to file all outstanding annual reports and financial statements by August 10, 2023.
- 9. Glorifi has not complied with the order and has failed to file the outstanding annual reports and financial statements.

Legal Allegations

- 1. GloriFi violated Tex. Ins. Code § 942.201 and 28 Tex. Admin. Code §7.68(f)(1) by not filing its annual report with TDI by March 1.
- 2. GloriFi violated 28 Tex. ADMIN. CODE § 7.68(f)(2) by not filing quarterly financial statements with TDI.
- 3. GloriFi is subject to its certificate of authority being suspended or revoked for failing to file its annual statement pursuant to Tex. Ins. Code § 801.057.
- 4. Glorifi has failed to comply with an order issued by the commissioner, as contemplated in Tex. INS. Code § 82.054.

Relief Sought

If one or more of the above allegations is found to be true, TDI asks the Administrative Law Judge to enter a Proposal for Decision recommending that the commissioner of insurance issue an order:

- 1. revoking GloriFi Reciprocal Insurance Exchange's certificate of authority, and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
