**General remarks and official action taken:**

This is a consent order with Professional Risk Solutions, LLC. Professional Risk Solutions, LLC failed to timely file surplus lines policies and related documents. Professional Risk Solutions, LLC has agreed to pay an administrative penalty of \$9,225 for these violations.

**Waiver**

Professional Risk Solutions, LLC acknowledges that the Texas Insurance Code and other applicable law provide certain rights. Professional Risk Solutions, LLC waives all of these rights, and any other applicable procedural rights, in consideration of the entry of this consent order.

**Findings of Fact**

1. Professional Risk Solutions, LLC, license number 1422138 holds a surplus lines license issued by the Texas Department of Insurance.
2. Pursuant to TEX. INS. CODE § 981.105(a), a surplus lines insurance agent must file with the Surplus Lines Stamping Office of Texas either:
  - a. a copy of the policy issued or

- b. if the policy has not yet been issued, a copy of the certificate, cover note, or other confirmation of insurance delivered to the insured.

This information is due not later than the 60th day after the later of the effective date or the issue date of new or renewal surplus lines insurance.

3. In 2023, Professional Risk Solutions, LLC filed surplus lines policies and related documents late.
4. In March 2024, TDI assessed fees against Professional Risk Solutions, LLC because the late-filed surplus lines policies met at least one of the conditions in TEX. INS. CODE § 981.105(d-e).
5. Professional Risk Solutions, LLC did not timely pay the fees assessed pursuant to TEX. INS. CODE § 981.105(c-e).
6. The commissioner previously disciplined Professional Risk Solutions, LLC for violating TEX. INS. CODE § 981.105(a) in Official Order No. 2016-4705, entered on October 7, 2016, Official Order No. 2022-7260, entered on March 9, 2022, and Official Order No. 2022-7600, entered on November 7, 2022.

## Conclusions of Law


1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, and 981.105.
2. The commissioner of insurance has authority to informally dispose of this matter under TEX. INS. CODE § 82.055, TEX. GOV'T CODE § 2001.056, and 28 TEX. ADMIN. CODE § 1.47.
3. Professional Risk Solutions, LLC has knowingly and voluntarily waived all procedural rights to which it may have been entitled regarding the entry of this order, including, but not limited to, issuance and service of notice of intention to institute disciplinary action, notice of hearing, a public hearing, a proposal for decision, rehearing by the commissioner, and judicial review.
4. Professional Risk Solutions, LLC violated TEX. INS. CODE § 981.105(a) by failing to timely file new or renewal surplus lines policies and related documents.




