General remarks and official action taken:

This is a default order taken against Shedrick Deyond Bables (Respondent) because he failed to respond to a request for information, is not actively engaged in soliciting or writing insurance for the public generally, and failed to timely notify the department of changes to his mailing and email addresses. Respondent did not respond to a Notice of Allegations mailed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Allegations

1. On May 27, 2025, the department sent a Notice of Allegations, attached as Exhibit A, to Respondent.
2. The department sent the Notice of Allegations to Respondent's last known address provided in writing to the department, [REDACTED], Lewisville, TX 75067.

3. Respondent received and waived an opportunity for a hearing because Respondent failed to send the department a written response to the Notice of Allegations within 20 days after the date the Notice of Allegations was mailed.
4. The department's factual allegations set out in the attached Notice of Allegations are incorporated in this order as findings of fact.

Conclusions of Law


1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.401; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE § 1.47.
3. The department provided proper notice to Respondent under TEX. GOV'T CODE §§ 2001.003(1), 2001.051, 2001.052, 2001.054, and 2001.056(4), and 28 TEX. ADMIN. CODE §§ 1.28, 1.47, and 19.906.
4. Based on Respondent's failure to send the department a written response to the Notice of Allegations, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE § 1.47.
5. Respondent failed to show compliance with the law.
6. The department's factual and legal allegations set out in the attached Notice of Allegations are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.47.



NOTICE OF ALLEGATIONS AGAINST SHEDRICK DEYOND BABLES

The Texas Department of Insurance (TDI) seeks to take disciplinary action against you. This Notice states the allegations against you and the relief sought by TDI.

YOUR WRITTEN RESPONSE IS REQUIRED WITHIN 20 DAYS

YOU HAVE THE RIGHT TO A HEARING AND ARE INVITED TO SHOW COMPLIANCE WITH THE LAW. To request a hearing, you must send a written response to TDI within 20 days of the date this Notice was mailed.

If you fail to send a written response by the deadline, *you waive your right to a hearing*, and TDI may seek disposition by default under 28 TEX. ADMIN. CODE § 1.47, TEX. INS. CODE § 82.055, and TEX. GOV'T. CODE § 2001.056.

If you fail to send a written response by the deadline, without further notice to you, the commissioner of insurance may issue a default order that admits the factual matters asserted, deems all allegations as true, and orders the relief recommended in this Notice.

A

Jurisdiction

The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051–82.055, 4001.002, 4005.101, 4005.102, and 4051.401; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.

Factual Allegations

Licensure

1. TDI issued Shedrick Deyond Bables (Bables), individual identification no. 2692015, a personal lines property and casualty agent license effective February 24, 2023.

Appointments Cancelled for Cause

2. Bables was employed by Allstate exclusive agent Avery Henderson and according to TDI's records, was appointed by Allstate Insurance Company and seven other Allstate affiliated insurers (collectively, Allstate) on March 7, 2023.
3. Allstate notified TDI it canceled Bables' appointments for-cause effective February 6, 2024. At the same time, Allstate canceled Henderson's and his other employees' appointments for-cause.

Failure to Designate New Email, Update Mailing Address, and Failure to Respond

4. Regulated persons are required to notify TDI within 10 business days if official TDI communications can no longer be received at the regulated person's designated email address.
5. According to TDI's records, Bables' designated email address for official TDI communications has an "Allstate" domain.
6. On March 22, 2024, TDI sent Bables a reasonable request for information about the for-cause cancellation of his Allstate appointments, pursuant to TEX. INS. CODE § 38.001. Because Allstate had canceled Bables, TDI sent this request to Bables' alternative "gmail" domain email address shown in TDI's records.
7. Bables' response was due by April 6, 2024.

8. On April 20, 2024, Bables replied from the "gmail" email address, claiming he sent his response to TDI by mail.
9. However, TDI did not receive any response.
10. On May 2, 2024, TDI again emailed Bables to inform him that TDI did not receive a response and requested Bables email it. Bables did not respond.
11. On October 24, 2024, TDI then sent the same request for information to Bables at his designated mailing address in TDI's records. That request was sent by first class mail and certified mail, return receipt requested, but the certified mail was returned to TDI on December 8, 2024, as undeliverable.
12. Bables failed to notify TDI on a monthly basis of a change to his mailing address.
13. Bables failed to respond to TDI's request for information.

Not Actively Engaged and Failed to Maintain Qualifications

14. Agents are required to maintain the qualifications necessary to obtain the license, including being or intending to be actively engaged in the soliciting or writing of insurance for the general public and being actively engaged in the business of insurance.
15. TDI records show Bables has no active appointments with any insurer in Texas, and has not had any appointments after Allstate canceled him for cause effective February 6, 2024.
16. For more than a year, Bables has not been actively engaged in soliciting or writing insurance for the public generally and has failed to maintain his qualifications for licensure.

Legal Allegations

1. Bables is not actively engaged in soliciting or writing insurance for the public generally as required by TEX. INS. CODE § 4001.104(a), and in violation of TEX. INS. CODE §§ 4005.101(b)(10) and 4001.254.

2. Bables failed to respond to a reasonable request for information from TDI, in violation of TEX. INS. CODE § 38.001(c).
3. Bables failed to notify TDI on a monthly basis of a change to his mailing address, in violation of TEX. INS. CODE § 4001.252(a)(1) and 28 TEX. ADMIN. CODE § 19.906.
4. Bables failed to notify TDI that official TDI communications could no longer be received at his designated Allstate email address, and he failed to designate a new email address within 10 business days after his Allstate appointments were canceled for cause, in violation of 28 TEX. ADMIN. CODE § 1.1302(c).

Relief Sought

TDI seeks the following relief:

1. revocation of your license; and,
2. imposition of any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.





