**General remarks and official action taken:**

This is a default order taken against Barrett C. Prody (Respondent) because he was convicted and incarcerated for felony continuing criminal enterprise, obstruction of justice, and conspiracy to money laundering. Respondent did not respond to a Notice of Allegations mailed by the Texas Department of Insurance (TDI). This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

**Findings of Fact**

Failure to Respond to Notice of Allegations

1. On April 4, 2025, TDI sent a Notice of Allegations, attached as Exhibit A, to Respondent.
2. TDI sent this Notice of Allegations to Respondent's last known address provided in writing to TDI, [REDACTED], Fargo, North Dakota 58102.
3. On June 6, 2025, TDI sent an Amended Notice of Allegations, attached as Exhibit B, to Respondent, after being made aware of Respondent's incarceration in a federal prison facility.

4. TDI sent this Amended Notice of Allegations to Respondent's last known address provided in writing to TDI and to the federal prison facility at which Respondent is being held, at P.O. Box 4000, Rochester, Minnesota, 55903.
5. Respondent received and waived an opportunity for a hearing because Respondent failed to send TDI a written response to the Notice of Allegations within 20 days after the date the Amended Notice of Allegations was mailed.
6. TDI's factual allegations set out in the attached Amended Notice of Allegations are incorporated in this order as findings of fact.

### Conclusions of Law

1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, and 4101.051; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051-2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE § 1.47.
3. TDI provided proper notice to Respondent under TEX. GOV'T CODE §§ 2001.003(1), 2001.051, 2001.052, 2001.054, and 2001.056(4); and 28 TEX. ADMIN. CODE §§ 1.28, 1.47, and 19.906.
4. Based on Respondent's failure to send TDI a written response to the Notice of Allegations, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE § 1.47.
5. Respondent failed to show compliance with the law.
6. TDI's factual and legal allegations set out in the attached Notice of Allegations are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.47.







The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051–82.055, 4001.002, 4005.101, 4005.102, and 4051.101; TEX. OCC. CODE §§ 53.021–53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.

## Factual Allegations

1. Barrett Prody (Prody) has a non-resident Adjuster All Lines license, number 2520953, issued by TDI on May 15, 2020.
2. In April 2024, Prody was indicted for felony Conspiracy to Possess with Intent to Distribute and Distribute Controlled Substance, felony Obstruction of Justice, and felony Aiding and Abetting.
3. On May 2, 2024, TDI sent Prody a request for information. He did not respond to the request for information.
4. On November 1, 2024, Prody pleaded guilty to the following charges in cause number 24-064 in the United States District Court for the District of North Dakota: Conspiracy to Possess with Intent to Distribute and Distribute a Controlled Substance (21 USC § 846), Obstruction of Justice (18 USC § 1503, 1512(i), 2), Money Laundering Conspiracy (18 USC § 1956 (h) and 2), and Continuing Criminal Enterprise (21 USC § 848(a) & 848(c) and 18 USC § 2).
5. On April 14, 2025, Prody was sentenced to 190 months in federal prison for felony Continuing Criminal Enterprise, 120 months for felony Obstruction of Justice, and 190 months for felony Money Laundering Conspiracy, to be served concurrently. Prody was committed to the custody of the Federal Bureau of Prisons to serve his sentence.

## Legal Allegations

1. Prody committed an act for which a license may be revoked, as contemplated by TEX. OCC. CODE §§ 53.021 – 53.023 and 28 TEX. ADMIN. CODE § 1.502.
2. Prody has committed a felony, as contemplated by TEX. INS. CODE § 4005.1001(b)(8).

3. Prody did not respond to TDI's request for information in violation of TEX. INS. CODE § 38.001.
4. Prody committed a felony that directly relates to the business of insurance, as contemplated in 28 TEX. ADMIN. CODE § 1.502(d)(1).
5. Prody has committed a felony involving moral turpitude as contemplated in 28 TEX. ADMIN CODE § 1.502(f)(3).
6. As contemplated in 28 TEX. ADMIN. CODE § 1.502(f)(8), Prody committed an offense under federal law that is substantially similar to an offense listed under 28 TEX. ADMIN. CODE § 1.502(f)(2)(B) which involves a money laundering offense as described by Penal Code Chapter 34 and § 1.502(f)(4)(T), which involves an offense relating to the manufacture, delivery, or possession with intent to manufacture or deliver, a controlled substance, a simulated controlled substance, a dangerous drug, or a volatile chemical.
7. TDI guidelines and 28 TEX. ADMIN. CODE § 1.502(c)-(f) emphasize that TDI:
  - a. Considers it very important that agents be honest, trustworthy and reliable;
  - b. May revoke a license if TDI determines that the applicant has committed a felony or misdemeanor;
  - c. Considers the offenses Conspiracy to Possess with Intent to Distribute and Distribute Controlled Substance, Obstruction of Justice, Money Laundering Conspiracy and Aiding and Abetting to be of such a serious nature that it is of prime importance when determining fitness for licensure, as 28 TEX. 8. Prody has been convicted of a criminal felony involving dishonesty or breach of trust, and may not engage in the business of insurance without the written consent of the Commissioner of Insurance as contemplated by 18 U.S.C. § 1033.
9. Upon entry into the custody of the United States Bureau of Prisons, Prody's adjuster license was revoked by operation of law as contemplated by TEX. OCC. CODE § 53.021(b).

1. Revocation of your license;
2. Imposition of any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.




