**General remarks and official action taken:**

This is a default order taken against Jack Leland Draper (Respondent) because he: was convicted of two felonies that directly relate to the business of insurance; failed to timely notify Texas Department of Insurance (TDI) of those felony convictions and a change to his mailing address when he became incarcerated; and, he failed to timely designate a new email address for TDI communications. Respondent did not respond to a Notice of Allegations mailed by TDI. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

**Findings of Fact**

Failure to Respond to Notice of Allegations

1. On October 20, 2025, the department sent a Notice of Allegations, attached as Exhibit A, to Respondent.
2. The department sent the Notice of Allegations to Respondent's last known address provided in writing to the department, PO Box 29105, Shawnee Mission, KS 66201-1405, and to an additional, designated inmate mailing address, Smart Communications, Jack Leland Draper, Inmate ID [REDACTED], PO Box 9216, Seminole, FL 33775-9195.

3. Respondent received and waived an opportunity for a hearing because Respondent failed to send the department a written response to the Notice of Allegations within 20 days after the date the Notice of Allegations was mailed.
4. The department's factual allegations set out in the attached Notice of Allegations are incorporated in this order as findings of fact.

### Conclusions of Law

1. The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051–82.055, 4001.002, 4005.101, 4005.102, 4056.053, 4101.051, and 4101.201; TEX. OCC. CODE §§ 53.021–53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE § 1.47.
3. The department provided proper notice to Respondent under TEX. GOV'T CODE §§ 2001.003(1), 2001.051, 2001.052, 2001.054, and 2001.056(4), and 28 TEX. ADMIN. CODE §§ 1.28, 1.47, and 19.906.
4. Based on Respondent's failure to send the department a written response to the Notice of Allegations, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE § 1.47.
5. Respondent failed to show compliance with the law.
6. The department's factual and legal allegations set out in the attached Notice of Allegations are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.47.





## **Jurisdiction**

The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051–82.055, 4001.002, 4005.101, 4005.102, 4056.053, 4101.051, and 4101.201; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.

## **Factual Allegations**

### Background and Licensure

1. The Texas Department of Insurance (TDI) issued Jack Leland Draper (Draper), individual identification no. 2183196, an adjuster designated home state (DHS) Texas license effective March 18, 2020.
2. At the time of licensure, Draper represented to TDI that his state of residence and residential address was in Wyoming, Michigan, and his mailing address was a post office box in Shawnee Mission, Kansas.
3. TDI records show that on February 24, 2025, Draper changed his residential address to a residence in Sparta, Michigan, but his designated mailing address in Shawnee Mission, Kansas remained unchanged.

### Two Criminal Convictions

4. On August 17, 2024, in case no. 24-09099-FH, in the 17th Judicial Circuit Court of Kent County, Michigan, Draper was charged by complaint with the following felonies, after he sent sexually charged messages and nude photos to an undercover agent posing online as a fourteen-year-old girl:
  - a. Count One: child sexually abusive commercial activity;

- b. Count Two: accosting children for immoral purposes, a "Tier II" offense under the Michigan Sex Offenders Registration Act (SORA);<sup>1</sup> and,
  - c. Count Three: computers - internet -communicating with another to commit a crime - maximum imprisonment of 15 years or more or life.
5. On May 5, 2025, the charges in case no. 24-09099-FH were amended by information to add Count Four: computers - using to commit a crime - maximum imprisonment of 4 years or more but less than 10 years.
6. Also, on May 5, 2025, in case no. 24-09099-FH, Draper pleaded guilty to felony Counts Two and Four. Counts One and Three were dismissed.
7. On July 14, 2025, in case no. 24-09099-FH, the 17th Judicial Circuit Court convicted Draper of Counts Two and Four by guilty plea, and sentenced him to 365 days in jail, with credit for five days served, to be followed by 60 months of probation.
8. Additionally, the Circuit Court ordered Draper to pay a total of \$1,326 in court costs, fees, and assessments on the date of sentencing. Draper was further ordered to register as a sex offender with a "\$30/MO O/S fee," which upon information and belief, is contemplated when the offender registers as a sex offender out of state.
9. Draper is shown publicly on Michigan's Sex Offender Registry with the status of incarcerated, beginning July 14, 2025.
10. Draper is also shown as incarcerated on the Kent County Correctional Facility's public website. According to the Correctional Facility's public website, the mailing address designated for its inmates is a post office box in Seminole, Florida.
11. Draper is not scheduled to be released from the Kent County Correctional Facility until May 9, 2026, at which time he is scheduled to begin probation for another 60 months.

## Failure to Notify TDI Monthly of Two Felony Convictions and Mailing Address Change

12. Texas law requires license holders to notify TDI on a monthly basis of changes to the license holder's mailing address and of a felony conviction.
13. Draper failed to notify TDI on a monthly basis of his two felony convictions.
14. Draper failed to notify TDI on a monthly basis that after he was sentenced to jail and that while serving his sentence, his mailing address has changed.

## Failure to Designate New Email

15. Regulated persons are required to notify TDI within 10 business days if official TDI communications can no longer be received at the regulated person's designated email address.
16. According to TDI's records, Draper's designated email address for official TDI communications has a "farmersinsurance" domain.
17. On June 5, 2025, TDI emailed Draper a reasonable request for information about his criminal charges at the email address designated by Draper in TDI's records. Later that day, a representative from Farmers Insurance replied to that email stating that the email address is no longer a good email address for Draper.

## **Legal Allegations**

1. Draper has been convicted of two felonies, in violation of TEX. INS. CODE § 4005.101(b)(8).
2. TDI may revoke Draper's license under TEX. OCC. CODE § 53.021(a)(1) and 28 TEX. ADMIN. CODE 1.502(d)(1), because he has been convicted of an offense that directly relates to the duties and responsibilities of the licensed occupation.
3. Draper has committed two felony offenses that directly relate to the duties and responsibilities of the licensed occupation, as contemplated in 28 TEX. ADMIN. CODE § 1.502(f)(3), (f)(4)(E), and (f)(4)(L).

4. Draper committed offenses that TDI considers to be of such a serious nature that they are of prime importance in determining fitness for licensure, as contemplated by 28 TEX ADMIN. CODE 1.502(f) and TEX. OCC. CODE §§ 53.021–53.023.
5. TDI guidelines, 28 TEX ADMIN. CODE § 1.502(c)-(f), emphasize that TDI :
  - a. considers it very important that licensees be honest, trustworthy, and reliable;
  - b. may revoke a license if TDI determines that the licensee has committed an offense that directly relates to the duties and responsibilities of the licensed occupation;
  - c. considers these offenses to be of such a serious nature that they are of prime importance when determining fitness for licensure:
    - (A) any felony offense involving moral turpitude;
    - (B) a sexual offense, as described by Penal Code Chapter 21; and
    - (C) any offense with the essential elements of online solicitation of a minor, as described by Penal Code § 33.021.
6. Draper failed to notify TDI on a monthly basis of:
  - a. a change of his mailing address, in violation of TEX. INS. CODE § 4001.252(a)(1); and
  - b. two felony convictions, in violation of TEX. INS. CODE § 4001.252(a)(2).
7. Draper failed to designate a new email address within 10 business days after official TDI communications could no longer be received at his designated email address, in violation of 28 TEX. ADMIN. CODE § 1.1302(c).

**Relief Sought**

TDI seeks the following relief:

1. revocation of your license; and
2. imposition of any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.






