**General remarks and official action taken:**

This is a default order taken against All Insurance 365 Agency Corporation (Respondent) because it: engaged in unauthorized acts of insurance in Texas; made a material misstatement in a license application; obtained a license by fraud or misrepresentation; engaged in fraudulent or dishonest acts or practices; and, failed to register an assumed name with TDI. Respondent did not respond to a Notice of Allegations mailed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

**Findings of Fact**

Failure to Respond to Notice of Allegations

1. On August 15, 2025, the department sent a Notice of Allegations, attached as Exhibit A, to Respondent.
2. The department sent the Notice of Allegations to Respondent's last known address provided in writing to the department, 1804 N. University Dr., Pembroke Pines, FL 33024.

3. Respondent received and waived an opportunity for a hearing because Respondent failed to send the department a written response to the Notice of Allegations within 20 days after the date the Notice of Allegations was mailed.
4. The department's factual allegations against this Respondent, as set out in the attached Notice of Allegations, are incorporated in this order as findings of fact.

### Conclusions of Law

1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051–82.055, 101.001 *et seq.*, 4001.002, 4001.101, 4001.106, 4005.101, 4005.102, 4051.051, 4054.051, and 4056.052; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE § 1.47.
3. The department provided proper notice to Respondent under TEX. GOV'T CODE §§ 2001.003(1), 2001.051, 2001.052, 2001.054, and 2001.056(4), and 28 TEX. ADMIN. CODE §§ 1.28, 1.47, and 19.906.
4. Based on Respondent's failure to send the department a written response to the Notice of Allegations, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE § 1.47.
5. Respondent failed to show compliance with the law.
6. The department's factual and legal allegations set out in the attached Notice of Allegations are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.47.



The Texas Department of Insurance (TDI) seeks to take disciplinary action against Cassandra C. Nicolas and All Insurance 365 Agency Corporation. This Notice states the allegations against you and the relief sought by TDI.

***YOUR WRITTEN RESPONSE IS REQUIRED WITHIN 20 DAYS***


**YOU HAVE THE RIGHT TO A HEARING AND ARE INVITED TO SHOW COMPLIANCE WITH THE LAW.** To request a hearing, you must send a written response to TDI within 20 days of the date this Notice was mailed.

If you fail to send a written response by the deadline, *you waive your right to a hearing*, and TDI may seek disposition by default under 28 TEX. ADMIN. CODE § 1.47, TEX. INS. CODE § 82.055, and TEX. GOV'T. CODE § 2001.056.

If you fail to send a written response by the deadline, without further notice to you, the commissioner of insurance may issue a default order that admits the factual matters asserted, deems all allegations as true, and orders the relief recommended in this Notice.

### **Jurisdiction**

The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051–82.055, 101.001 *et seq.*, 4001.002, 4001.101, 4001.106, 4005.101, 4005.102, 4051.051, 4054.051, and 4056.052; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.

### **Factual Allegations**

#### Licensure of Cassandra Nicolas

1. Cassandra C. Nicolas (Cassandra Nicolas), individual identification number 3034194, holds a non-resident general lines agent license with a life, accident, health, and HMO qualification issued by TDI on October 25, 2024.
2. Cassandra Nicolas has a Texas non-resident license because her resident state is Florida.

#### Administrative Actions against Cassandra's Relative - Jean Nicolas

3. Upon information and belief, Cassandra Nicolas is related to Jean Mario Nicolas (Jean Nicolas).
4. TDI records show Jean Nicolas, individual identification number 1978204, held a non-resident general lines agent license with a life, accident, health, and HMO qualification issued by TDI on October 16, 2018, but the license was revoked in Official Order No. 2025-9330, effective June 9, 2025.
5. TDI records show that Jean Nicolas held a Texas non-resident license because his resident state was Florida.
6. On November 20, 2024, the Florida Department of Financial Services, Division of Insurance Agent and Agency Services issued a consent order in case number 335357-24-AG which suspended Jean Nicolas' insurance licenses for 12 months – until at least November 20, 2025.

7. Shortly thereafter, after learning that Jean Nicolas' license was suspended in Florida - TDI likewise suspended Jean Nicolas's non-resident general lines agent license effective December 5, 2024 - as required by TEX. INS. CODE § 4056.052(c).
8. According to public records of the Florida Department of State, Division of Corporations (Florida Department of State), the sole officer and/or director of All Insurance 365 Insurance Corporation from the corporation's formation in 2016 up until April 23, 2025, was Jean Nicolas.
9. After investigation of the Florida suspension, on April 23, 2025, TDI sent its Notice of Allegations to Jean Nicolas, informing him of certain alleged misconduct and the relief TDI intended to seek – including revocation of his license and an order mandating that he cease and desist from engaging in the business of insurance in Texas, individually, and under or through any other entities or names, including "All Insurance 365."
10. However, the same day that TDI sent Jean Nicolas its Notice of Allegations, All Insurance 365 Agency Corporation (All Insurance 365) filed its 2025 annual report with the Florida Department of State, stating that Jean Nicolas is its president and adding Cassandra Nicolas as a manager.
11. Jean Nicolas did not respond to TDI's Notice of Allegations, and so, on June 9, 2025, the Commissioner of Insurance entered the Order granting TDI's requested relief, revoking Jean Nicolas's license and also ordering him to cease and desist from engaging in the business of insurance in Texas, individually, and under or through any other entities or names, including All Insurance 365.
12. In the Order, the Commissioner made findings of fact that Jean Nicolas had his Florida license suspended, failed to notify TDI of that suspension, and assisted an unlicensed entity with engaging in the business of insurance. The Commissioner also concluded that Jean Nicolas engaged in fraudulent or dishonest acts or practices, failed to maintain qualifications to maintain his non-resident Texas license, and directly or indirectly engaged in the unauthorized business of insurance.

#### Material Misstatements in Agency License Application

13. On April 23, 2025 – the same day TDI sent the Notice of Allegations to Jean Nicolas – Cassandra Nicolas submitted a non-resident general lines agency license

application to TDI for All Insurance 365. All Insurance 365 applied as a non-resident because its resident state is Florida.

14. On April 24, 2025, TDI granted All Insurance 365, firm identification number 225757, a non-resident general lines agency license with a life, accident, health, and HMO qualification.
15. In the agency's license application submitted to TDI, Cassandra Nicolas failed to disclose and intentionally concealed material information from TDI, specifically Cassandra Nicolas did not list Jean Nicolas in the part of the application requiring that the agency identify all owners, officers, and persons controlling the agency.
16. Moreover, in the agency's license application, Cassandra Nicolas falsely answered "no" to the following question:

Has the business entity or any owner, partner, officer or director of the business entity, or manager or member of a limited liability company, ever been named or involved as a party in an administrative proceeding, including a FINRA sanction or arbitration proceeding regarding any professional or occupational license, or registration?
16. The application defined "involved" to include a license suspension and being named as a party to an administrative proceeding, related to a professional or occupational license or registration.
17. Cassandra Nicolas's response on behalf of All Insurance 365 was false, misleading, and deceptive because:
  - a. All Insurance 365 has another controlling person and officer, Jean Nicolas;
  - b. Jean Nicolas' license was suspended in Florida in case number 335357-24-AG; and,
  - c. Jean Nicolas was named in a TDI administrative proceeding that began the very same day Cassandra Nicolas submitted All Insurance 365's license application to TDI.
18. Cassandra Nicolas made this material misstatement and omitted naming or disclosing Jean Nicolas as a controlling person of All Insurance 365, in order for All Insurance 365 to obtain an insurance license.

Failure to Register Assumed Name with TDI

18. Prior to and after Cassandra Nicolas was designated as a manager of All Insurance 365, it used and continues to use the assumed name "ObamaCare365."
19. However, TDI records show that All Insurance 365 has not registered that assumed name with TDI.

Unauthorized Agent Acts

20. All Insurance 365 advertises and solicits on its website [www.obamacare365.com](http://www.obamacare365.com) (the Website) that it not only sells health insurance – which it is authorized to do – but it also advertises and solicits general liability, personal auto, commercial auto, and commercial property insurance.
21. The Website is viewable by citizens of Texas.
22. According to TDI's records, neither Cassandra Nicolas nor All Insurance 365 hold a license or qualification to solicit general liability, personal auto, commercial auto, or commercial property or casualty insurance in Texas. Nor are they exempt or excepted from holding the appropriate license or qualification for those lines of business.
23. As a result:
  - a. All Insurance 365 is engaging in unlicensed and unauthorized acts of insurance in Texas; and,
  - b. Cassandra Nicolas is directing, controlling, and otherwise assisting All Insurance 365 d/b/a ObamaCare365 with engaging in unlicensed and unauthorized acts of insurance in Texas.

Failure to Respond to Inquiry

24. On July 8, 2025, TDI emailed and mailed a request for information to Cassandra Nicolas, informing her that she must respond no later than 15 days after the receipt of the inquiry.
25. On July 12, 2025, Cassandra Nicolas received TDI's inquiry, but did not respond.

### **Legal Allegations**

1. Cassandra Nicolas failed to respond to TDI's written inquiries not later than the 15th day after the date of the inquiry, in violation of TEX. INS. CODE § 38.001.
2. Cassandra Nicolas and All Insurance 365 have directly or indirectly engaged in the business of insurance, as those acts are defined by TEX. INS. CODE §§ 101.051, 4001.003(1), and 4001.051, and in violation of TEX. INS. CODE §§ 101.102(a), 4001.101, and 4001.106.
3. Cassandra Nicolas and All Insurance 365 each committed acts for which a license holder may be disciplined under TEX. INS. CODE §§ 4005.101 and 4005.102 because they:
  - a. intentionally made a material misstatement in a license application, in violation of TEX. INS. CODE § 4005.101(b)(2);
  - b. obtained or attempted to obtain a license by fraud or misrepresentation, in violation of TEX. INS. CODE § 4005.101(b)(3); and,
  - c. engaged in fraudulent or dishonest acts or practices in violation of TEX. INS. CODE § 4005.101(b)(5).
4. Cassandra Nicolas and All Insurance 365 failed to register an assumed name with TDI, in violation of 28 TEX. ADMIN. CODE § 19.902.

### **Relief Sought**

TDI seeks the following relief:

1. revocation of Cassandra C. Nicolas's license;
2. revocation of All Insurance 365 Agency Corporation's license;
3. an order mandating that Cassandra C. Nicolas cease and desist from engaging in the business of insurance in Texas, individually and under or through any other entities or names, including All Insurance 365 Agency Corporation and ObamaCare365; and
4. imposition of any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.




