**General remarks and official action taken:**

This is a default order taken against Jeromie Lee Reed (Respondent) because he made a material misstatement on a license application, obtained or attempted to obtain a license by fraud or misrepresentation, and engaged in fraudulent or dishonest acts or practices. Respondent did not respond to a Notice of Allegations mailed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

**Findings of Fact**

Failure to Respond to Notice of Allegations

1. On June 16, 2026, the department sent a Notice of Allegations, attached as Exhibit A, to Respondent.
2. The department sent the Notice of Allegations to Respondent's last known address provided in writing to the department, [REDACTED], Columbia, Missouri 65203. The department also sent the Notice of Allegations to Respondent's electronic mail address he last designated for receipt of official department communications, and to an additional address associated with Respondent: [REDACTED], Independence, Missouri 64057.

3. The department gave Respondent notice and opportunity for a hearing, which Respondent waived by failing to send a written response to the Notice of Allegations within 20 days after the date it was mailed.
4. The department's factual allegations set out in the attached Notice of Allegations are incorporated in this order as findings of fact.

### **Conclusions of Law**

1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, 4056.051, 4056.053, 4101.051, and 4101.201; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051-2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE § 1.47.
3. The department provided proper notice to Respondent under TEX. GOV'T CODE §§ 2001.003(1), 2001.051, 2001.052, 2001.054, and 2001.056(4), and 28 TEX. ADMIN. CODE §§ 1.1302, 1.28, 1.47, and 19.906.
4. Based on Respondent's failure to send the department a written response to the Notice of Allegations, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE § 1.47.
5. Respondent failed to show compliance with the law.
6. The department's factual and legal allegations set out in the attached Notice of Allegations are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.47.

**Order**

It is ordered that any licenses held by Jeromie Lee Reed are revoked. A copy of this order will be provided to law enforcement or other appropriate administrative agencies for further investigation as may be warranted.

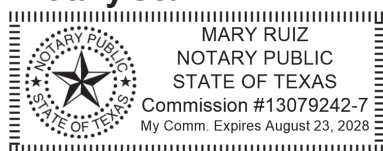

If you fail to send a written response by the deadline, without further notice to you, the commissioner of insurance may issue a default order that admits the factual matters asserted, deems all allegations as true, and orders the relief recommended in this Notice.

## **Jurisdiction**

The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051–82.055, 84.021–84.044, 4001.002, 4005.101, 4005.102, 4056.051, 4056.053, 4101.051, and 4101.201, TEX. OCC. CODE §§ 53.021–53.023, 28 TEX. ADMIN. CODE § 1.502, and TEX. GOV'T CODE §§ 2001.003(1) and 2001.051–2001.178.

## **Factual Allegations**

### Licensure

1. Jeromie Lee Reed (Reed), individual identification number 1618647, holds a designated home state adjuster license issued by the department on June 9, 2016.

### Criminal History

2. On or about March 23, 2021, Reed had an adjudication withheld for one count of Battery and one count of Trespass in Occupied Conveyance Refusal to Leave, misdemeanors, in Orange County, Florida.
3. At the end of a romantic relationship, Reed began repeatedly contacting his former girlfriend for the purpose of causing her distress. This contact continued despite Reed being told to no longer contact the female and despite his arrest for harassment of the female. Additionally, Reed sent private images of his former girlfriend to other people and caused emergency services to be dispatched to her home for a false report that she was unconscious.
4. On December 22, 2023, Reed was charged by Complaint with the offense of Nonconsensual Dissemination of Private Sexual Images, a felony, in Case Number 23PT-CR01684 in the 18th Circuit Court of Pettis County, Missouri.
5. On December 22, 2023, Reed was charged by Complaint with the offense of Harassment, a felony, in Case Number 23PT-CR01684 in the 18th Circuit Court of Pettis County, Missouri.

6. On December 22, 2023, Reed was charged by Complaint with the offense of Harassment, a felony, in Case Number 23PT-CR01684 in the 18th Circuit Court of Pettis County, Missouri.
7. On December 22, 2023, Reed was charged by Complaint with the offense of Making a False Report, a misdemeanor, in Case Number 23PT-CR01684 in the 18th Circuit Court of Pettis County, Missouri.
8. On February 8, 2024, Reed was charged by Complaint with the offense of Harassment, a felony, in Case Number 24PT-CR00151 in the 18th Circuit Court of Pettis County, Missouri.
9. On February 8, 2024, Reed was charged by Complaint with the offense of Violation of Order of Protection For Adult, a misdemeanor, in Case Number 24PT-CR00151 in the 18th Circuit Court of Pettis County, Missouri.
10. On or about October 23, 2024, Reed was charged by Information for the offense of Violation of Order of Protection For Adult, a misdemeanor, in Case Number 24PT-CR01674 in the 18th Circuit Court of Pettis County, Missouri.
11. On or about October 23, 2024, Reed was charged by Information for the offense of Harassment, a misdemeanor, in Case Number 24PT-CR01674 in the 18th Circuit Court of Pettis County, Missouri.

#### Misrepresentation on License Renewal Applications

12. Reed submitted applications to renew his license in 2020, 2022, and 2024.
13. On his 2022 and 2024 renewal applications, Reed falsely answered "No" to the following:

Have you been convicted of a misdemeanor, had a judgment withheld or deferred, or are you currently charged with committing a misdemeanor, which has not been previously reported to this insurance department?

Have you been convicted of a felony, had a judgment withheld or deferred, or are you currently charged with committing a felony,

which has not been previously reported to this insurance department?

14. At the time of his 2022 renewal application, Reed had completed a deferred adjudication probation for a misdemeanor in Florida.
15. At the time of his 2024 renewal application, Reed had been charged with the felony offense of Nonconsensual Dissemination of Private Sexual Images, three charges for the felony offense of Harassment, two charges for the misdemeanor offense of Violation of Order of Protection For Adult, a misdemeanor charge for Harassment, and a misdemeanor charge for Making a False Report.

### **Legal Allegations**

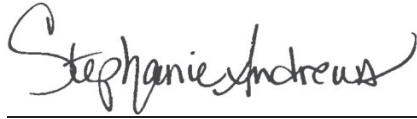
1. Reed willfully violated an insurance law of this state, in violation of TEX. INS. CODE § 4005.101(b)(1).
2. Reed intentionally made a material misstatement on the license application, in violation of TEX. INS. CODE § 4005.101(b)(2).
3. Reed obtained or attempted to obtain a license by fraud or misrepresentation, in violation of TEX. INS. CODE § 4005.101(b)(3).
4. Reed has engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).

### **Relief Sought**

TDI seeks the following relief:

1. revocation of your license;
2. an administrative penalty under TEX. INS. CODE §§ 84.021 and 84.022; and
3. imposition of any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.

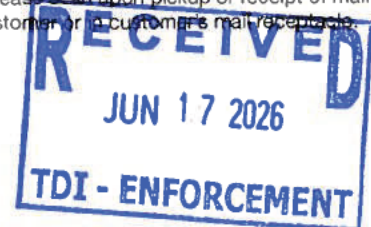
