## PRODUCT DESCRIPTION

The Series 1000 windows are aluminum single hung windows. The aluminum single hung windows evaluated in this report are individual, non-impact resistant windows. The aluminum single hung windows evaluated in this report are based on the following tested constructions:

**Glass Construction Key:**

IG-1: The operable sash and the fixed sash contain sealed insulating glass units. The sealed insulating glass units are comprised of two minimum double strength ( $\frac{1}{8}$ "") annealed glass lites separated by a desiccant-filled aluminum spacer system. The glass thickness and type used in the tested assembly and in smaller assemblies shall comply with ASTM E 1300-04.

**Glazing Method Key:**

GM-1: The insulating glass units in both the active sash and the fixed sash are interior glazed with a silicone backbedding compound. The insulating glass units are secured in place with a snap-in aluminum glazing bead.

**Frame Construction:** The frame is manufactured of extruded aluminum. The frame members are not thermally broken. The frame corners are butt construction and are secured together with two (2) screws at each corner. The fixed meeting rail is secured to the frame side jambs with two (2) screws at each end.

**Sash Construction:** The operable sash is manufactured of extruded aluminum. The sash members are not thermally broken. The sash corners are butt construction and are secured together with two (2) screws per corner.

**Hardware:**

- Cam type sweep lock; Two (2) required; Located 9 inches from each end of the active meeting rail.
- Keepers; Two (2) required; Located on the fixed meeting rail at the lock positions.
- Single block and tackle side load balance system; Two (2) required; Located in each interior jamb track.

**Reinforcement:** None.

**Product Identification:** A certification program label (NAMI) will be affixed to the window. The certification program label shall include the manufacturer's name (**All Seasons Commercial Division**); product name (**1000 Aluminum Single Hung Window**); performance characteristics; the approved inspection agency (NAMI); and the applicable standard: AAMA/WDMA/CSA 101/I.S.2/A440-05.

**LIMITATIONS**

**Design pressures:**

**Impact Resistance:** These window assemblies do not satisfy the Texas Department of Insurance's criteria for protection from windborne debris. These window assemblies will need to be protected with an impact protective system if installed in areas where windborne debris protection is required.

**Acceptance of Smaller Assemblies:** Windows assemblies with dimensions equal to or smaller than those specified above are acceptable within the limitations specified in this report.

**INSTALLATION INSTRUCTIONS**

**General:** The window assembly shall be installed in accordance with the manufacturer's installation instructions. Detailed drawings and installation instructions are available from the manufacturer.

**Installation:** The wood framing members shall be minimum Southern Yellow Pine dimension lumber. The window shall be secured to the wall framing utilizing minimum  $1 \frac{3}{4}$ " x  $\frac{3}{4}$ " wood blind stops along the interior and the exterior side of the window. The blind stops are required along the full perimeter of the window. The blind stops are secured to the wall framing with minimum No. 8 x  $1 \frac{5}{8}$  inch screws. The fasteners shall be located approximately 3 inches from each corner and approximately 12 inches on center. All fasteners shall be long enough to penetrate a minimum of  $1 \frac{1}{2}$  inches into the wall framing.

**Note:** The manufacturer's installation instructions shall be available on the job site during installation. All fasteners shall be corrosion resistant as specified in the International Residential Code (IRC), the International Building Code (IBC), and the Texas Revisions.
