#### Installation:

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing through the side jambs. Locate No. 8 x 2-3/8" PPH screws through the center of the side jamb. Locate No. 6 x 2-1/2" screws approximately 4" from each corner along the side jambs. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing.

**Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
