#### **Installation:**

### Frame Installation (System 1-2):

The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing using minimum No. 10 x 2-1/2" wood screws. Locate the screws approximately 6" and 26" from each corner along the head, 26" from each end along the sill, and 6" from each corner along the side jambs. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

**Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
