#### **General Description:**

The Traco TR-9100 aluminum single hung windows are used for commercial installation. This evaluation report includes the following assemblies:

• Individual Single Hung Side Load Window

**Product Identification:** A Kawneer label will be affixed to the window assembly. The label includes the manufacturer's name (Kawneer); the product name (Traco TR-9100 Windows-Single Hung); the design pressures (+/- 50 psf); the max. assembly size (60"w x 99"h); the configuration (O/X); TDI drawing I-NI-9100-001; and the test standards (AAMA/WDMA/CSA 101/I.S.2/A440-08).

## **Compliance:**

The window assemblies were tested for compliance with AAMA/WDMA/CSA 101/I.S.2/A440-08; however, they are not certified by an inspection agency and do not bear a performance label from an inspection agency. The window bears a label produced by the manufacturer.

The window assemblies passed test criteria equivalent to ASTM E330-14.

#### Limitations:

**Design Drawings:** The window assemblies must comply with and be installed in accordance with the following design drawings:

• Drawing No. I-NI-9100-001, titled "TR 9100 Single Hung Side Load Window, Non-Impact;" Sheets 1 thru 3 of 3; dated April 30, 2012; signed and sealed by Lucas A. Turner, P.E. on March 3, 2022. This evaluation report refers to the stated drawing as the approved drawing.

**Fabrication and Assembly:** Kawneer window systems are fabricated in the factory. The aluminum window system is assembled and glazed at the jobsite. The approved drawings referenced in this evaluation report indicate the options for the glazing construction.

**Design Pressure (DP):** The aluminum window system has a maximum design pressure rating of +50 / -50 psf. Refer to the approved drawing for specific design pressure requirements.

**Impact Resistance:** The window system does not satisfy TDI's criteria for protection from windborne debris. Provide an impact protective system when installing the product in areas that require windborne debris protection.

#### **Installation Instructions:**

**General:** Prepare and install the assembly in accordance with Kawneer's installation instructions and the approved drawing specified in this report. Detailed installation instructions are available from Kawneer.

**Wall Framing Construction:** The window system may be mounted to several types of wall framing construction. The types of wall framing constructions allowed include:

- Concrete (minimum compressive strength: 2,000 psi)
- CMU (concrete filled)
- Wood (minimum specific gravity, SG=0.42)
- Steel (minimum 1/8" thick, Fy=36 ksi)
- Metal stud (minimum 16-gauge, 33 ksi)
- Aluminum (minimum 1/8" thick, 6063-T5)

Refer to the design drawing for specific wall construction requirements.

### **Fastener Requirements:**

- Refer to the approved drawing for anchor layout and notes
- Refer to the approved drawing for the minimum embedment depths for the fasteners and the minimum edge distanced (minimum distance fastener must be from the edge of the substrate material) for the fasteners.
- **Note:** Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
