## General remarks and official action taken:

The subject of this default order is whether a general lines life accident and health license should be issued to Cherrelle Dionne Jones (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

## **Findings of Fact**

## Failure to Respond to Notice of Hearing

- 1. On January 7, 2020, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, TX 77640-4258.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- The commissioner has jurisdiction pursuant to Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, and 4005.101-4005.105; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. Gov't Code § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. Admin. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. Admin. Code §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. ADMIN. CODE § 1.89.

#### ORIGINAL PETITION

The Texas Department of Insurance (department) seeks to deny Cherrelle Dionne Jones' (Jones) license application. In support of this petition, the Department makes the following allegations upon information and belief:

#### Jurisdiction

The commissioner of insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4054.051; Tex. Gov'T Code §§ 2001.051-2001.178; and 28 Tex. Admin. Code § 1.502; and Tex. Occ. Code §§ 53.021 – 53.023.

## **Factual Allegations**

## **Licensing Application**

- Jones submitted an application for a general lines life accident and health license to the department on May 16, 2018, in which she failed to disclose her criminal history.
- The department proposed to deny Jones' license on August 21, 2018, based on her criminal history and her failure to disclose said criminal history. The department received Jones request for a hearing on September 5, 2018.

## Misrepresentation on Application

 On Jones' license application, when asked if she had ever been convicted of a felony crime, Jones failed to disclose her criminal history. Jones falsely stated that she had never been convicted of a felony.

## Criminal History

- 4. On November 4, 2010, a jury found Jones guilty of Felony Neglect of a Child and sentenced her to a term of ten years with the Mississippi State Department of Corrections, to serve four years with the remainder on probation, in the 22<sup>nd</sup> Circuit District Court of Jefferson County, Mississippi, in cause number 2010-30KRB.
- Jones was released from felony probation on May 31, 2017.

## Texas Criminal Equivalent

6. The offense in Jones' Mississippi conviction, contains the essential elements of Tex. PENAL CODE § 22.041, which criminalizes abandoning or endangering a child.

## **Legal Allegations**

- Jones has attempted to obtain a license by fraud or misrepresentation, as contemplated by Tex. Ins. Code § 4005.101(b)(3).
- Jones has engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. Ins. Code § 4005.101(b)(5).
- 9. Jones has been convicted of a felony as contemplated by Tex. INS. CODE § 4005.101(b)(8).
- 10. Jones committed an offense that the department considers to be of such a serious nature that it is of prime importance in determining fitness for licensure, as contemplated by 28 Tex. ADMIN. CODE § 1.502(e)(4)(B).
- 11. Department guidelines, 28 Tex. ADMIN. CODE § 1.502(c)-(e), emphasize that TDI:
  - a. considers it very important that applicants be honest, trustworthy, and reliable;

- may refuse to issue an original license if the department determines that the applicant has committed a felony or misdemeanor that directly relates to the duties and responsibilities of the licensed occupation; and
- c. considers the offense of endangering a child/felony neglect of a child to be of such a serious nature that it is of prime importance when determining fitness for licensure. 28 Tex. ADMIN. Code § 1.502(e)(4)(B).

## Relief Sought

If one or more of the above allegations is found to be true, the Department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Jones' license application; and
- 2. any other just and appropriate relief to which the Department may be entitled to by law.
