General remarks and official action taken:

This is a consent order with McAnally Wilkins, Inc (McAnally Wilkins). McAnally Wilkins failed to timely file surplus lines policies and related documents. McAnally Wilkins has agreed to pay an \$2,225 administrative penalty for these violations.

Waiver

McAnally Wilkins acknowledges that the Texas Insurance Code and other applicable law provide certain rights. McAnally Wilkins waives all of these rights, and any other applicable procedural rights, in consideration of the entry of this consent order.

Findings of Fact

- 1. McAnally Wilkins, organization identification number 37412, holds a surplus lines license issued by the Texas Department of Insurance.
- 2. Pursuant to Tex. Ins. Code § 981.105(a), a surplus lines insurance agent must file with the Surplus Lines Stamping Office of Texas either:
 - a. a copy of the policy issued or
 - b. if the policy has not yet been issued, a copy of the certificate, cover note, or other confirmation of insurance delivered to the insured.

This information is due not later than the 60th day after the later of the effective date or the issue date of new or renewal surplus lines insurance.

- 3. In 2020, McAnally Wilkins filed surplus lines policies late.
- 4. In March 2021, TDI assessed fees against McAnally Wilkins because the late-filed surplus lines policies met at least one of the conditions in Tex. INS. CODE § 981.105(d-e).
- 5. McAnally Wilkins did not timely pay the fees assessed pursuant to Tex. Ins. CODE § 981.105(c-e).

Conclusions of Law

- 1. The commissioner of insurance has jurisdiction over this matter pursuant to TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, and 981.105.
- 2. The commissioner of insurance has authority to informally dispose of this matter under Tex. Ins. Code § 82.055, Tex. Gov't Code § 2001.056, and 28 Tex. Admin. Code § 1.47.
- 3. McAnally Wilkins has knowingly and voluntarily waived all procedural rights to which it may have been entitled regarding the entry of this order, including, but not limited to, issuance and service of notice of intention to institute disciplinary action, notice of hearing, a public hearing, a proposal for decision, rehearing by the commissioner, and judicial review.
- 4. McAnally Wilkins violated Tex. Ins. Code § 981.105(a) by failing to timely file new or renewal surplus lines policies and related documents.
