### General remarks and official action taken:

This is a consent order with Venture Agency Holdings Inc, who failed to timely file surplus lines policies and related documents. Venture Agency Holdings Inc has agreed to pay an administrative penalty of \$100,000 for these violations.

#### Waiver

Venture Agency Holdings Inc acknowledges that the Texas Insurance Code and other applicable law provide certain rights. Venture Agency Holdings Inc waives all these rights, and any other applicable procedural rights, in consideration of the entry of this consent order.

## **Findings of Fact**

- 1. Venture Agency Holdings Inc (VAH), organization identification number 105448, holds a surplus lines license issued by the Texas Department of Insurance.
- 2. Pursuant to Tex. Ins. Code § 981.105(a), a surplus lines insurance agent must file with the Surplus Lines Stamping Office of Texas either:
  - a. a copy of the policy issued, or

b. if the policy has not yet been issued, a copy of the certificate, cover note, or other confirmation of insurance delivered to the insured.

This information is due not later than the 60th day after the later of the effective date or the issue date of new or renewal surplus lines insurance.

- 3. In 2020, VAH filed surplus lines policies late.
- 4. The commissioner previously disciplined VAH for violating Tex. INS. CODE § 981.105(a) in Official Order No. 2020-6515, entered on October 22, 2020, which concerned surplus line policies VAH filed late in 2019.
- 5. In late 2019, VAH represents it completed an audit and discovered policies issued in multiple years that had not been submitted for stamping. VAH immediately took corrective action, reported the error, started filing the policies that should have been filed previously, and paid the associated taxes, fees, and penalties. VAH represents it completed the corrective effort in 2020.

## **Conclusions of Law**

- 1. The commissioner of insurance has jurisdiction over this matter pursuant to Tex. INS. CODE §§ 82.051-82.055, 84.021-84.044, and 981.105.
- 2. The commissioner of insurance has authority to informally dispose of this matter under Tex. Ins. Code § 82.055, Tex. Gov't Code § 2001.056, and 28 Tex. Admin. Code § 1.47.
- 3. VAH has knowingly and voluntarily waived all procedural rights to which it may have been entitled regarding the entry of this order, including, but not limited to, issuance and service of notice of intention to institute disciplinary action, notice of hearing, a public hearing, a proposal for decision, rehearing by the commissioner, and judicial review.
- 4. VAH violated Tex. Ins. Code § 981.105(a) by failing to timely file new or renewal surplus lines policies and related documents.

#### Order

It is ordered that Venture Agency Holdings Inc must pay an administrative penalty of \$100,000. The administrative penalty must be paid within 90 days from the date of this

order. The administrative penalty must be paid as instructed in the invoice, which the department will send after entry of this order.
