General remarks and official action taken:

This is a default order taken against Lindsay Marie Coy (Respondent) because she submitted fictitious information to an insurance company, bound an insurance policy without the insured's consent, and failed to respond to department inquiries. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

1. On March 23, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, [REDACTED], [REDACTED], Austin, TX 78726-2238.
4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101-4005.102, 4051.051 and 4054.051; TEX. OCC. CODE §§ 53.021-53.023; and TEX. GOV'T CODE §§ 2001.051-2001.178.
2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
3. The department provided proper notice of the hearing under TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.89.

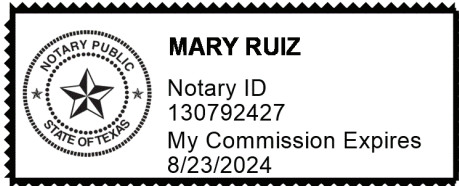

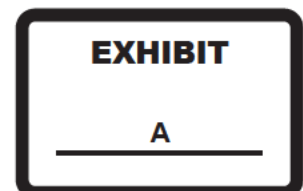

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Lindsay Marie Coy. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.101, 4005.102, 4051.051 and 4054.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

1. Lindsay Marie Coy (Coy), individual identification number 1347856, holds a general lines agent license with a property and casualty qualification originally issued by the Texas Department of Insurance (TDI) on July 17, 2014, and a life, accident, health, and HMO qualification issued on July 21, 2022.
2. On February 15, 2021, Coy contracted with Firefly Agency LLC (Firefly) as an independent agent.
3. Soon after Coy began working for Firefly, Firefly received a consumer call concerning a policy the consumer had purchased from Coy that was not active.
4. Firefly subsequently investigated Coy's sales and found that 32 of Coy's 58 customer policies contained fraudulent behaviors including unauthorized

signatures, unauthorized use of bank account numbers, and the use of incorrect driver's license numbers to avoid higher premiums.

5. On November 10, 2021, Firefly terminated Coy's contract.
6. On January 10, 2022, Coy contracted to work as an independent agent for Hippo Analytics Inc (Hippo).
7. According to Hippo's records, the following activities occurred at Hippo:
 - On March 11, 2022, Coy was issued a warning for binding a policy without the consumers consent.
 - On May 4, 2022, a Hippo audit revealed that Coy was sending applications to herself instead of the applicant for signatures.
 - On May 5, 2022, Hippo confronted Coy about the information revealed in the audit and Coy stated that she had received verbal consent from the applicants to sign the documents. Coy was suspended pending an investigation.
 - On May 6, 2022, Coy was terminated after an audit of her calls revealed that Coy had not obtained verbal consent to sign the documents.
8. On June 6, 2022, TDI's Consumer Protection (CP) division received a complaint from Coy's direct supervisor at Hippo indicating that Coy had bound multiple policies without the insured's consent or knowledge and provided false information to consumers regarding their coverage.
9. On June 10, 2022, CP sent a written request for information regarding the Hippo complaint to Coy's email of record, indicating a required response. Coy failed to respond to CP's inquiry.
10. On August 25, 2022, TDI sent a written inquiry by certified mail to Coy's address of record and by email, indicating a required response. No response was received by TDI.

11. On September 27, 2022, TDI sent a second inquiry by certified mail to Coy's address of record and by email, indicating a required response. No response was received by TDI.

Legal Allegations

1. Coy committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated by TEX. INS. CODE § 4005.102.
2. Coy engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).
3. Coy failed to respond to TDI's written inquiry within the statutory time limit, in violation of TEX. INS. CODE § 38.001.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

1. revoking Lindsay Marie Coy's license; and
2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.

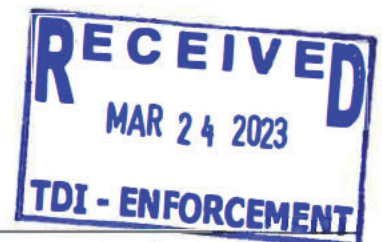
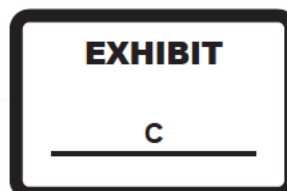
